

**TRAVIS COUNTY EMERGENCY SERVICES DISTRICT 1 & 7  
JOINT COMMISSIONERS' COUNCIL MEETING MINUTES  
DECEMBER 10, 2025**

- I. Call to Order at 3:39 p.m. by Commissioner Mark Evert.  
Roll Call: Present: Commissioner Cameron, Commissioner Evert, Commissioner O'Brien, Commissioner Surginer. Also present was Chief Norman, Dr. Hancock, Medical Director, Chief Weidman, and Deputy Fire Marshall Collier. Not present Commissioner Finley.
- II. Citizens' Comments: None.
- III. ESD 1: Motion by Commissioner Cameron to approve treasurer's report for period ending November 30, 2025, including all invoices over \$2,000.00 and any budget amendments. Seconded by Commissioner Surginer. Amendments to the budget included \$2,000,000 in the TIFMAS reimbursement income line and \$650,000 increase in the TIFMAS expense line. All voted aye and the motion passed 4-0.

- IV. Motion by Commissioner O'Brien to approve combined regular meeting minutes from November 12, 2025, for both ESD1 and ESD7. Seconded by Commissioner Cameron. All voted aye and the motion passed 4-0.
- V. Motion by Commissioner O'Brien to approve Austin Fire Dispatch Agreement. Seconded by Commissioner Surginer. All voted aye and motion passed 4-0.

- VI. Motion by Commissioner O'Brien to approve purchase of two Braun ambulances from Siddons-Martin with a June 2028 delivery date. Seconded by Commissioner Cameron. All voted aye and motion passed 4-0. This motion was amended from one ambulance to two ambulances due to cost.
