**Treasurer's Report:** Anticipating bill for Mike Bickford's work with brontosaurus (~\$4,750). Roughly 5 acres cleared over 3 days. Woodcock habitat and apple tree release. Habitat will be maintained in future with brush hog. Goal is to maintain singing males (8 previously observed). Over time, the 30 acre old-field area should be maintained and kept open per management plan. Future goal: release remaining apple trees (50 or so).

Parking area to be included in plan. Matt will provide draft amendment at October Subcommittee meeting for review. Final purchase and closing to occur by end of October.

September 18, 4 to 6pm, Walk & Talk event with NorthWoods Stewardship Center board and community members to discuss the town forest and NWSC role in management.

September 25, 4pm walk with Mike Morin and folks involved with the Northern Forest Center who are interested in forest projects addressing climate change. Cliff and Hank will help lead discussion on Town Forest history. Matt will lead discussion on forestry work and climate-focused projects.

Trail Signs: Bob donated material used for posts and signs. Signs laser-engraved by Rick Angell, The Foundry (Lyndon Institute). Almost all signs are up (4 remaining). Rick asked us not to send \$\$ donations but to give a good word in article(s) about The Foundry.

New Business: Think about 2026 projects/budget and start discussion at the October meeting.
