## Stockgrowers' Legislative Issues

Our Brand Board bill, HB 1252 was killed by the House Ag. Committee last week. Despite terrific testimony from Stockgrowers which demonstrated the many problems and the lack of accountability that are the status quo for the Brand Board, the majority of the committee was unmoved.

We've added SB 195 to our watch list below. SB 195 modifies the process to change or vacate a section-line highway. The bill requires the commissioner of school and public lands to review any petitions to vacate, change, or relocate a highway to ensure compliance with the requirements of § 31-3-6.1 which bars counties and townships from vacating a highway which provides access to public lands or public waters embracing an area of not less than forty acres. If the commissioner finds the petition violates the terms of § 31-3-6.1 then the petition is void. Any adverse decision by the commissioner may be appealed to the circuit court.

Rep. Trish Ladner's bill, HB 1208, to require the director of equalization to adjust certain agricultural land values died on the House floor Monday.

Rep. Liz May's landowner rights bill, HB 1251, to modify provisions related to the annexation of unplatted territory or agricultural land was also killed Monday by the full House.

On the property rights/pipeline/eminent domain front SB 201 passed the Senate Commerce committee this week. That bill strips all local control over any gas or liquid transmission line or electric transmission line which requires or holds a permit under chapter 49-41B. Counties, municipalities, and townships would be barred from imposing any requirement or restrictions as to routing, setback, construction, operation, maintenance, and zoning permits. The bill would void any existing local requirements in those areas. SB 201 will be heard by the full Senate on Wednesday the 21st.
