Includes but is not limited to 24-hour availability to respond to initial request for service; arrangement conference (pre-need and/or at-need); recording vital statistics; administrative duties to facilitate final disposition; securing other forms and claims; preparation and submission of death notices/obituaries; Benefits assistance (*see below); coordination of service plans with all parties involved with final disposition of the deceased.
