2023 PCSC AGM Minutes

Park City Soccer Club 2023 Annual General Meeting Minutes
Blair Education Center, Park City Hospital • March 29, 2023

The PCSC Annual General Meeting started at 6:35pm. Shelley Gillwald, Executive Director, opened the meeting by introducing herself and stating she would be hosting the meeting in the absence of Board President, Michelle Oxton.

Shelley took roll call of the Board followed by Team Representatives. Board members Mercedes Betemps, Chris Bullock, Thomas Cooke, and Brian McCallion were in attendance, along with Sr. Staff / Ex Officio members Shelley Gillwald and Eli Ulvi. All teams 32 competitive teams and 2 Foundations teams were represented with at least one team agent.

Confirmation of 2023 AGM Meeting Notice was presented by Shelley Gillwald, with notification and reminder send to the full Club membership electronically on March 6 and March 20.

The 2022 AGM Minutes, from March 30, 2022, were reviewed. A motion to approve was made by Thomas Cook and seconded by Chris Bullock. The minutes were unanimously approved by verbal yea/nay vote.

Starting with staff reports, Shelley first provided a club overview by the numbers, mentioning 663 players, 547 families, 34 teams playing in 585 games and attending 97 tournaments, and awarding over \$108,000 to 103 scholarship recipients (80 of whom are fulltime club players.)

Eli Ulvi gave his Technical Director report, discussing the goal to develop overall scheduling consistency, including introducing more pool play and supplemental training. He discussed coaches' education, including First Aid / CPR training, SafeSport certification, and the license levels of our coaching staff. Eli also acknowledged the frustration of limited indoor training space and reminded all that it takes a village.

Shelley gave the Executive Director's Report, first recognizing Club sponsors and the various Club initiatives and activities over the year. She also explained the scholarship program and its funding sources, followed by a review of the 19th Annual Extreme Cup and the 2023/24 Club Calendar of Events.

Shelley then went on to explain the Club's new Work Deposit Policy (an update of the Club's Volunteer Policy.) Due to a significant lack of volunteer engagement, in 2023/24 the Club is changing the deposit to \$500 and the number of required hours to 15. Families will have until

August 31, 2023, to complete their hours and submit the google form (to be tracked by the Club electronically) to avoid the \$500 deposit. For those not completing their hours by August 31, their work deposit will be due by September 15, but will have until May 31, 2024, to complete their hours and receive a full refund. Deposits can be made through a payment plan if needed.

Brian McCallion gave the Financial Report which reviewed 2023/24 program fees. Fees did not increase for competitive programs, and only saw a nominal increase for Foundations and Futures due to the raise in indoor expenses incurred by those programs. Brian reiterated the \$500 refundable work deposit, and uniform expenses for families new to the Club. He also reminded those in attendance that other than the Extreme Cup, tournament fees are additional.

The proposed 2023/24 budget was reviewed with proposed balanced budget totaling \$1,007,000+, including over \$5,000 in contingency fees. Brian explained variances over the projected 2022/23 FYE numbers and a yay/nay vote was taken. The budget was approved.

Brian continued with the next portion of the meeting, discussing the Board of Director structure and current members. For the 2023/24 board elections there are three open seats: two serving a two-year term and one one-year term, completing Dana Witkin's term as she is requesting to be moved to an appointed one-year team. Three of the four candidates introduced themselves and spoke briefly about their goals for serving the Club: Dominic Burchett, Tracy Fike, and Lauren Hanley. Brian mentioned the 4th candidate, Michelle Oxtan and her 1.5-year history as the Board President.

Board elections were held via written vote, with team representatives turning in their ballots at the desk on their way out. Results are to be posted online within 24 hours.

Eli opened the floor to questions before Shelley adjourned the meeting at 7:50 pm.

Executive Director's Remarks Our Scholarship Program

PCSC's Scholarship Program

It is the philosophy of PCSC to provide any qualified child the opportunity to play soccer, regardless of their ability to pay. That said, all scholarship recipients are required to pay a portion of their fees and complete their family volunteer hours.

We are fortunate to have a number of funding vehicles which enable us to assist so many children annually, without ever utilizing the fees paid by our membership to underwrite the program.

Our Scholarship Impact

- ◆ In 2023/24, PCSC will award over \$117,000 in scholarship support
 - Assist with annual program fees
 - Provide uniforms
 - Help with team fees and lodging for travel tournaments
 - Two PC Community Scholarships to graduating senior players
- ◆ Supporting 106 year-round players and 10 Futures players

Scholarship Funding

- ◆ **Live PC Give PC**
 - Chaired by Dana Witkin and backed by generous matching gifts from Friends of PCSC, this year's LPCGPC raised more than \$46,500 as the basis of our scholarship funding.
- ◆ **Grants & Donations**
 - Funding partners such as the Solomon Fund, Utah Youth Soccer have a huge impact
- ◆ **20th Park City Extreme Cup Tournament**
 - The Extreme Cup funds travel assistance for our scholarship recipients on competitive teams, ensuring every player has the chance to join their team for tournament play.*

**The Tournament Travel Fund is also available for non-scholarship recipients in hardship situations.*



Executive Director's Remarks

Our Tournament: PC Extreme Cup



"As we prepare for the 21st Annual Park City Extreme Cup, the PCSC membership should take pride as hosts of one of the largest and most highly regarded tournaments in the Intermountain West. To date the Extreme Cup has raised over \$1,000,000 in support of the Club's need-based scholarship fund and programming initiatives." -Cora Lucero, Tournament Director

Why Host A Tournament?

Financial Stability for the Club

- The Extreme Cup generates \$100,000 annually
- The tournament helps fund over 100 need-based scholarships and enables those players to participate in travel tournaments
- The tournament helps underwrite winter training expenses and coaches' education
- Without the Extreme Cup, program fees would increase approximately \$250 - \$300 per player

Home Field Advantage

- PCSC teams participate on their own fields, hosting thousands of competitors, for free!

- ◆ In 2023, games were played in Park City, Kamas Valley & Heber
 - 452 teams of girls and boys ages U9 - U19 played in 64 brackets
 - Over 8,400 players, coaches and officials participated
 - 815 games were played on 42 fields at 15 venues
 - It took nearly 225 referees per day to officiate the tournament
- ◆ The Extreme Cup Executive Committee worked 2,600+ hours planning
 - It takes over 4,500 tournament time hours to host the event
