If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. Michigan law does, however, require embalming in cases such as when certain infectious diseases caused death, or when the body isn't taken to its final destination (cemetery, crematory, medical school or other) within 48 hours. If a delay is caused by other than Walter Scott Skupny Funeral Home (i.e. medical examiner, doctor, hospital, family, etc.) it is deemed selected and authorized, and it will be charged for.
