

# **BEXXJONES.COM PRIVACY POLICY**

Bexxjones.com, bexxsecretgarden.com & bexxmusic.com takes your privacy very seriously. This Privacy Policy sets forth our commitment to you regarding your privacy and security on the bexxjones website (the "Site"). This Privacy Policy will detail the categories of information we collect from bexxjones users, how we use such information, and how you can access the information that we have and make changes or remove it.

## **Personal Information**

This site does not collect personal information **without your knowledge.**

However, when you fill out a form on the "Contact Us" page and click the "Send" button the personal information that you entered is sent to us by e-mail and is also copied to your e-mail account. Therefore, the personal information that you entered is stored on both our e-mail server and yours.

We will only use your information to contact you regarding the reason you contacted us. We will not sell or rent this information to anyone nor will we share it with any third party outside of our organization.

This Privacy Policy is issued based upon our commitment to you and in conformity with California Business and Professions Code section 22575. For EU residents, special considerations may apply as set forth below.

By using the site, you are accepting the practices described in this privacy policy. These practices may be changed, but any changes will be posted here. The changes will only apply to activities and information on a going forward, not retroactive, basis. You are encouraged to review the privacy policy whenever you visit the site to make sure that you understand how any personal information you provide will be used. We reserve the right to make changes to this policy and any such changes will be posted on this page before they go into affect.

## **IP Address**

This site does NOT record your IP address.

## **Categories of Information Collected**

The Site collects both personally identifiable information (which is information specific and personal to you) and non-personally identifiable information (which is aggregate information that does not identify you).

## **Collection and Use of Information**

### **General**

### **Cookies**

A cookie is a small text file that is stored on a user's computer for record-keeping purposes. We use cookies on the Site. We do not link the information we store in cookies to any personally identifiable information you submit while on our site. By your use of the Lunarpages website you consent to allow us to place cookies on your computer and to access them as you navigate our website.

We use session ID cookies which expire when you close your browser. These cookies make it easier for you to navigate our site. If you reject

cookies, you may still use our site, but your ability to use some areas of our site, such as contests or surveys, will be limited.

The Site may links to other sites that are not owned or controlled by bexxjones. Please be aware that we are not responsible for the privacy practices of such other sites.
