Jim Fabry was born in Sharon, PA and, with his wife Dee, has lived in 7 states before moving to Estero in 2017 from San Diego. Prior to retiring, Jim's career was in Sales and Marketing management for 23 years at Kellogg's Sales Company. The last 12 years was with Texture Technologies as Western Regional Sales Manager.

While in Denver, CO, he was on the Board of Directors of the US Association for Blind Athletes (a division of the US Olympic Committee) from 1989-1995. He and Dee attended the Paralympics in Barcelona, Spain as guides for blind athletes and participated in many of their fundraisers. This ignited his passion for service, and is the accomplishment that he is most proud of. He joined Rotary in 2017 and has had many accomplishments since then, including Club President, Rotarian of the Year, Member of the Rotary Int'l Foundation Bequest Society, Major Donor 2 Rotary Int'l Foundation, District 6960 Area 2 Governor, Co-chair for District 6960 Wheelchair Foundation, sponsoring a Tsering Fund child for complete education, writing a grant for and raising awareness for Advent Health's Cleft Palate program.

Jim has attended RLI 1, 2, 3, and graduate classes, and volunteers his time with Cafe of Life, Meals of Hope, Bonita Springs Assistance Office, Harry Chapin, and Interfaith Charities. And if that wasn't enough, he's always willing to help our club when he's asked. In his free time, Jim enjoys playing with their dog, Zekee, and playing golf with fellow Rotarians.
