- ♦ 1959: A new facility is built at our current flagship location at 537 North Superior Street.

- ♦ 1988: Dan and Joanne Densow purchase the funeral home from the Wichmann family.
- ♦ 1998: A huge year of expanding our services to families! The Fargo Funeral Homes, Kaukauna and Kimberly merged with Wichmann Funeral Home, Appleton. In this year, we also acquired Fox Cities Funeral Home, Town of Menasha, and named it the Wichmann Funeral Home Tri-County Chapel.
- ♦ 2014: Dan Densow along with his son Lucas Densow purchased Martens Laemmrigh Funeral Home in Menasha and renamed it Wichmann Funeral Home Laemmrigh Chapel.
- ♦ 2016: Our entire downtown Appleton facility was reimagined and renovated to include soaring ceilings, an abundance of natural lighting, and a beautiful reception room for catered luncheons.
- ♦ 2021: Park Lawn Corporation purchased Wichmann Funeral Homes & Crematories from the Densow family. Dan Densow continues to serve as a Consultant alongside the same local management team and staff. All are sincerely committed to providing the highest level of compassionate service that the Wichmann name has stood for for over 125+ years.

You may choose only the items you desire; **however, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. ### **Professional Services**

#### **A. BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF (non-declinable) \$3,095**

Our charge includes, but is not limited to staff, facilities, and vehicles to respond to initial requests for service 24 hours every day, consultation with the survivors, coordinating service plans with cemetery, crematory, and/or other parties involved in the final disposition of the deceased, procuring death certificates and permits, consultation and assistance with procuring various death benefits, accounting and billing, regulatory compliance, legal and audit fees, postage, printing and supplies, telephones, insurance, salaries and benefits for our staff, and various county, state and federal taxes and fees. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our packages, direct cremations, immediate burials, and forwarding or receiving remains.)

#### **B. USE OF FACILITIES AND STAFF FOR FUNERAL OR MEMORIAL SERVICE \$475**

Staff and facilities necessary for conducting services desired OR if facilities are not used the additional time, staff, and equipment necessary for conducting the services off premises.

#### **C. USE OF FACILITIES AND STAFF FOR GATHERING/VIEWING/FAMILY TIME \$325**

Staff, facilities, and equipment necessary for conducting the above services OR if facilities are not used the additional time, staff, and equipment necessary for conducting the gathering off premises. The charges are for gatherings for a maximum of four (4) hours. Additional charges will be incurred for gatherings of longer duration.

#### **D. USE OF EQUIPMENT AND STAFF FOR COMMITTAL AND/OR INTERMENT SERVICES \$325**

Staff and equipment necessary for conducting graveside or mausoleum committal and/or interment services. Funeral services and visitations held at cemetery facilities are off-premise services and not committal services, and because of the additional time required and additional equipment used, they are billed as off-premise funerals.

#### **E. WEEKEND SERVICE FEE \$695**

For any service/gathering/event scheduled any time Saturday or Sunday.

#### **F. EMBALMING OR ALTERNATIVE CARE & REFRIGERATION \$925**

**EMBALMING** is a surgical procedure which requires written permission to perform. The purpose of this procedure is to disinfect and sanitize the remains and thus protect the public and staff from complications of decomposition. Embalming provides temporary preservation and allows the survivors to hold services at a time convenient to them. Included in the charge for embalming are all staff charges related to the procedure and the necessary equipment, chemical and facilities, as well as all costs related to the proper disposal of all medical waste, chemical waste and all equipment and materials necessary for compliance with the OSHA and ADA standards relating specifically to the embalming procedure. *Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it such as direct cremation or immediate burial.*

**ALTERNATIVE CARE & REFRIGERATION** is required when embalming is not performed. This is a temporary means of holding the remains until disposition occurs. It does not preserve or disinfect the remains for purposes of viewing. If for religious or other reasons embalming is declined, Wisconsin Statutes (HSS 136.04) requires a licensed embalmer to perform alternative sanitary care of the deceased.

**All costs related to compliance with the Federally Mandated OSHA Standards are included.**

## **G. OTHER PREPARATION OF THE DECEASED** **\$325**

Includes cosmetology, normal restoration of features, hair styling, dressing, and placement of the deceased in the casket, and any other necessary procedures to make the deceased ready for viewing and/or services.

## **H. TRANSFER OF DECEASED TO FUNERAL HOME** **\$575**

Includes necessary professional licensed staff and specialized vehicle and equipment for the removal of the deceased from the place of death to the funeral home, 24 hours per day, 365 days per year.

## **I. TRANSPORTATION**

All transportation charges contained within this list apply to an area described as within a radius of 35 miles to our Downtown Appleton location. If we exceed this service area, we will make an additional charge of **\$3.50 per mile** one way for a service vehicle.
