If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. Professional Services

A. BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF \$3,345

Our charge includes, but is not limited to staff, facilities, and vehicles to respond to initial requests for service 24 hours every day, consultation with the survivors, coordinating service plans with cemetery, crematory, and/or other parties involved in the final disposition of the deceased, sheltering of the deceased, procuring death certificates and permits, consultation and assistance with procuring various death benefits, accounting and billing, regulatory compliance, legal and audit fees, postage, printing and supplies, telephones, insurance, salaries and benefits for our staff, various county, state and federal taxes and fees. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.

B. EMBALMING \$695

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. Colorado law does require that the deceased be embalmed or refrigerated if the final disposition is not achieved within 24 hours following death.

- Add \$195 for additional time and materials when an autopsy or donation has been performed.

Includes cosmetology, any restorative art, hairdressing, dressing, and placement of the deceased in the casket.

* The modified refrigeration charge may apply when there is no embalming, but the presence of the deceased is preferred. For practical reasons and to comply with Colorado law requiring embalming or refrigeration after 24 hours from the time of death (CRS 12-135-106), we are able to strategically utilize cooling packs. While much less effective than embalming and invoking more risk of physical deterioration, this can allow for private viewing for up to 2 hours in our facility (where we are best able to manage any issues) and/or a closed casket service at the location of your choice. Usually, this will add a casket/container and Other Preparation of the Deceased.

Cremation Services

The degree to which we have loved is proportionate to the need to grieve. Routinely, I see co-workers and staff celebrants learning about the life of the person who died and creating healing moments to lift people up and lend meaning. Our facilities are modern and designed for hospitality, multi-media, and gatherings of almost any size. The Direct Cremation Options include sheltering/refrigeration for up to 4 days (other cremationists charge extra for each day of refrigeration). We also provide a windowed room that allows you to be present for the start of the cremation process. There is a charge of \$595 to reserve the room and cover the additional time of our staff.

You can rest assured that we cremate one individual at a time and diligently remove and track all cremated remains.

Horan & McConaty is the only firm in our state to offer this unique safety feature.

Personal inspections - We are the region's first crematory to encourage each family's personal inspection of our facilities. We also offer a special viewing room located next to our crematory for those who wish to be present for the start of the cremation.

Certified experts - Our staff receives advanced certifications to perform cremations. We strictly adhere to our own Cremation Code of Ethics-your assurance of our commitment to honesty and dignity.

FINAL IDENTIFICATION OF THE DECEASED

Cremation is an irreversible process. Where there is human involvement, there will always be the potential for human error. This can apply to hospital, coroner and mortuary staffs. To be safe and sure, for your peace of mind and ours, we highly recommend a positive identification of the deceased before cremation. In our memorial service and direct cremation option, there is no embalming and only a limited time that the deceased may be transferred out of refrigeration and identified (refrigeration or embalming are required by state law 24 hours after death — CRS 12-135-106). We provide two different cremation viewing options. For a full explanation of these, please refer to the Cremation Viewing Options sheet (see page 8).

Receiving A Deceased Person From Another Mortuary

MINIMUM DELIVERY TO CEMETERY

\$2,395

This discounted package includes Basic Services of Funeral Director and Staff (discounted to reflect already secured death certificate/disposition permit and reduced involvement of other personnel), Transfer to Mortuary from airport or other point in the metro area, and the Use of Funeral Coach or Van to a local cemetery. This package presumes no ceremony and no other use of the funeral home and that we may deliver to the cemetery at the time of our choosing. Add to the fee of \$2,395 any additional services selected, such as Graveside Ceremony, Other Preparation — dressing/casketing, Viewing and Funeral Service at chapel or church. If the forwarding arrangements to Denver are made directly by the family with a forwarding director, eliminating the need for our staff to meet and coordinate any details with the family, this discounted package will be further reduced by \$175.

Forwarding A Deceased Person To Another Mortuary

Immediate Burial

\$3,795 to \$22,295

Immediate burial is the process of arranging for burial of the unembalmed body as soon as possible. This service is preferred by members of the Jewish faith, especially Orthodox and Conservative, and Muslim faiths. We offer separate, specially configured facilities for ritual washing as dictated by the religious faiths we serve. Our staff is also fully knowledgeable in serving these faith communities.

Difficulties in filing a death certificate and securing the necessary legal permit immediately and/or a cemetery's inability to open a grave on short notice may require that the body be embalmed (\$695) or refrigerated (\$95 per day) so as to comply with State of Colorado health regulations requiring a sanitary disposition of the deceased within 24 hours (CRS 12-135-106). We include 4 days of refrigeration at no extra charge. The casket must stay closed at all times in order to comply with company policy and state law that the deceased be in a refrigerated state.

Immediate Burial options presume that we deliver the deceased to the cemetery for burial at the time of our choosing and that there is no viewing or commemorative gathering involved. This discounted package includes Basic Services of Funeral Director and Staff, Transfer to Mortuary from place of death, Other Preparation, dressing/casketing, Use of Funeral Coach to local cemetery and utility vehicle.

This package applies when Horan & McConaty is not involved in the care of the deceased and the survivors would like to use one of our chapels and/or reception centers. Our onsite reception centers make the transition from the service to the informal enjoyment of food and drink seamless. Our facilities are modern and immaculate and our charges are less than most hotels or country clubs, especially taking into account room rental plus food and beverage minimums which can be significant at such venues. For those who wish, we allow you to provide (without markup from us) beer, wine, and liquor for a ceremonial toast and can suggest area liquor stores that deliver (we provide certified bartenders at a reasonable cost to help ensure people are served appropriately). Our fee includes the creation of a memorial video, which can incorporate photos and video, audio-video equipment. When desired, we can provide a Certified Celebrant™, an additional fee, to tailor the service with you to reflect the meaning and uniqueness of one's life. We can assist with flowers, provide reception options and menus for those who wish, and will organize any mementos for display. Most importantly, we are kind, professional, and skilled in making things easier for you while looking after the myriad details.

Mailing of Cremated Remains

We can package, transport and mail cremated remains by U.S. Postal Service Express Mail anywhere in the United States for \$295 (add cost of urn). Other carriers will not accept cremated remains. Express Mail is typically an overnight delivery in the continental U.S. Because we schedule our crematory days in advance, and due in part to the time involved in meeting the legal requirements of the death certificate and disposition permit, we ask for 3-4 days following death to complete the cremation process. Let us know if this creates difficulty — we'll try our best to accommodate you.

Cremation Viewing Options

Pre-cremation Viewing

By choosing the *Pre-cremation Viewing*, your immediate family members (spouse, children, grandchildren, parents or siblings) are offered the opportunity to view your loved one for up to 30 minutes so that as a family, you will be afforded the opportunity to gather together for a final goodbye with your loved one. This *Immediate Family Viewing* will take place between the hours of 10:00 am and 3:00 pm, Monday through Saturday. We will ensure a natural appearance by bathing and dressing your loved one in clothing provided by your family. Our highly trained cosmetologist will wash and style your loved one's hair, apply any necessary cosmetics and provide appropriate manicuring to their nails. Viewing will take place in a private viewing room in the family's chosen cremation container. By selecting this option, there is a charge of \$495.00 for the additional preparation and any necessary transportation. This viewing may take place at any one of our locations. If the Pre-cremation Viewing is required to expedite the cremation (48 hour rule), the cost is still \$495.00.

Full Preparation Viewing

By choosing *Full Preparation Viewing*, an unlimited number of your family and friends are offered the opportunity for viewing, and greeting of friends for up to 2 days. With full preparation services, your family will be afforded the opportunity to have viewing and sharing with family and friends from 8:00 am to 8:00 pm, Monday through Saturday. With this option, our skilled professionals will provide the necessary embalming and preparation. We will ensure a peaceful look on your loved one's face along with bathing and dressing your loved one in clothing provided by your family. Our highly trained cosmetologist will wash and style your loved one's hair, apply any necessary cosmetics and provide appropriate manicuring to their nails. Viewing will take place in a private viewing room in the family's chosen casket or cremation container. By selecting this option, there will be an additional cost of \$695.00 for Embalming, \$495.00 for other preparations and \$495.00 per day for visitation. Viewing is allowed at any of our locations at no additional cost.

Witness Cremation

By choosing this service, your immediate family members (spouse, children, grandchildren, parents or siblings) are offered the opportunity to view your loved one for up to 30 minutes so that as a family you will be afforded the opportunity to gather together for a final goodbye with your loved one. This *Pre-Witness Immediate Family Viewing* will take place immediately prior to the scheduled time of the witness cremation. We will ensure a natural appearance by bathing and dressing your loved one in clothing provided by your family. Our highly trained cosmetologist will wash and style your loved one's hair, apply any necessary cosmetics and provide appropriate manicuring to their nails. Viewing will take place in a private viewing room in the family's chosen cremation container. This option is only offered at our Parker Road (at Dartmouth) location and is typically scheduled at 9:00 AM the day of the witness cremation. By selecting this option, there is a charge of \$595.00.
