**PARTICIPANT AGREEMENT
AND RELEASE FORM**

In consideration of the services of One Elite All Star Cheerleading, LLC its managing members, owners, coaches, employees, contractors, volunteers and all other persons or entities acting on its behalf, I hereby agree to release and discharge One Elite All Star Cheerleading, LLC and all of the above on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

YOU ARE AGREEING TO LET YOUR MINOR CHILD OR YOURSELF (STUDENTS 18 YRS OF AGE OR OLDER) ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF "ONE ELITE ALL STAR CHEERLEADING, LLC" USES REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD OR YOURSELF (STUDENTS 18 YRS OF AGE OR OLDER) MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CAN NOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM YOU ARE GIVING UP YOUR CHILD'S RIGHT OR YOUR RIGHT (STUDENTS 18 YRS AGE OR OLDER) AND ALL RIGHTS OF OTHERS TO RECOVER FROM "ONE ELITE ALL STAR CHEERLEADING, LLC" IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY BEING PERFORMED. YOU HAVE A RIGHT TO REFUSE TO SIGN THIS FORM AND "ONE ELITE ALL STAR CHEERLEADING, LLC" HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.

Should One Elite All Star Cheerleading, LLC or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.

I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no mental or physical conditions which could interfere with my safety in this activity or else am willing to assume and bear the costs of all risks that may be related, directly or indirectly, by such condition.

I, the undersigned, do hereby voluntarily submit my application for my child's attendance and participation in all activities with One Elite All Star Cheerleading, LLC.

I do hereby assume full responsibility for all damages, injuries, and/or losses that my child may sustain or incur, if any, while participating, and I hereby waive all claims against One Elite All Star Cheerleading, LLC, all associated coaches, managing members, owners, employees, contractors and volunteers for any claims or injuries my child may sustain.

I, the undersigned, understand and accept the risk of possible contact with individuals, who have been exposed to and/or have been diagnosed with one or more communicable diseases, including but not limited to COVID-19. I understand it is impossible to eliminate this risk. I, the undersigned, release One Elite from any responsibility if my athlete should contract any virus or disease, including COVID-19 while participating in any activity in the gym. I understand I am letting my child participate at my choice and assume all responsibility for sickness or even death. I, the undersigned, understand my child is participating at his/her own risk.

I, the undersigned, understand One Elite's premises (inside public areas) are under video and audio recording at all times. I understand by agreeing to this release, I am giving consent for video and audio recording of my child and myself within One Elite's premises.

MEDIA RELEASE

For good and valuable consideration, the receipt of which is hereby acknowledged, I hereby consent to the photographing of my child and the recording of my child's voice and the use of these photographs and/or recordings singularly or in conjunction with other photographs and/or recordings for advertising, publicity, commercial or other business purposes. I understand that the term "photograph" as used herein encompasses both still photographs and motion picture footage. ONE ELITE TERMS AND CONDITIONS

ACCOUNT/FINANCIAL OBLIGATIONS

Parent/s of the cheerleader are responsible for their child's account with One Elite. Responsibilities include any and all monthly tuition fees, uniform, practice wear as well as any additional competition costs/expenses or any additional items needed for competition such as cheer shoes, etc. Parents and minor children who turn 18 while in the program, along with children who are 18 at time of registration, are jointly responsible. If any account balances become delinquent for services rendered, then One Elite will refer your account to a collection agency.

One Elite will not get involved in any domestic natures, nor will we provide any information to any individual not listed on the account registration, unless the account holder requests such in writing.

TUITION /PAYMENT AND MAKEUP/REFUND POLICY

TUITION IS DUE ON THE 1ST PRACTICE OF EACH MONTH.

IF MONTHLY TUITION IS NOT PAID BY THE 5TH OF THE MONTH, THEN ATHELTE WILL SIT OUT UNTIL IT IS PAID. IF NOT PAID BY THE 15TH OF THE MONTH THEN A REPLACEMENT WILL BE PUT IN, WHICH WILL BECOME PERMENANT IF TUITION IS NOT PAID BY THE END OF THE MONTH. AT THAT POINT, WE WILL HAVE NO CHOICE BUT TO DISMISS YOUR CHILD FROM THE PROGRAM. IF YOUR PAYCHECK PERIODS, REQUIRE A DIFFERENT SCHEDULE, WE DO NOT MIND ACCOMODATING THIS AS LONG AS IT IS DISCUSSED IN ADVANCE AND AGREED UPON DATES ARE MET EVERY MONTH.

NO MAKE-UPS OR REFUNDS ARE GRANTED FOR ATHLETES TEAM PRACTICES OR GROUP CLINICS. NO REFUNDS WILL BE GIVEN AT ANY TIME SHOULD YOUR CHILD DECIDE TO LEAVE ONE ELITE ALL STAR CHEELEDING, LLC FOR ANY REASON (including due to injury) OR IF A CHILD IS ASKED TO LEAVE FOR DISCIPLINARY REASONS PERTAINING TO THEMSELVES OR THEIR PARENT; THIS INCLUDES BUT IS NOT LIMITED TO ALL FEES PAID TO ONE ELITE ALL STAR CHEERLEADING, LLC SUCH AS UNATTENDED COMPETITIONS AND OR TEAM PRACTICE SESSIONS AS WELL AS MERCHANDISE DEPOSITS(practice wear/uniforms), HOTEL ROOMS, BUS RIDES, ETC.ALL FUNDS RECEIVED FROM FUNDRAISING, BUT ESP FROM A BOOSTER CLUB ARE NON-REFUNDABLE. **ANY REMAINING BOOSTER CLUB FUNDS WILL BE USED TO PAY ANY OUTSTANDING DEBT ON AN ATHLETE'S ACCOUNT. AFTER THE ACCOUNT IS PAID IN FULL, INCLUDING EARLYWITHRAWAL/DISMISSAL FEE ANY REMAINING BALANCE WILL BE DISTRIBUTED BY ONE ELITE TO ANOTHER ATHLETE SINCE ALL BOOSTER CLUB FUNDS ARE TECHNICALLY A DONATION MADE TO ONE ELITE ALL STARS FROM THE BOOSTER CLUB. TO REFUND ANY BOOSTER CLUB FUNDS DIRECTLY TO AN INDIVIDUAL WOULD BE CONSIDERED A TAX EVASION.**

IN THE CASE OF ANY UNFORSEEN PANDEMIC CLOSING, YOU WILL BE CREDITED FOR ANY COMPETITIONS FULLY CHARGED/PAID FOR AS LONG AS THE COMPETITION COMPANY REFUNDS US. OUR TUITION IS ALL INCLUSIVE OF MULTIPLE ITEMS, WHICH MEANS YOUR COMPETITION FEES ARE NOT FULLY PAID FOR UNTIL THE LAST PAYMENT IN APRIL IS PAID.

IF YOUR CHILD SHOULD QUIT OR BE DISMISSED FROM ONE ELITE ALL STAR CHEERLEADING, LLC , DUE TO VIOLATION OF ANY OF OUR TERMS AND CONDITIONS/GYM RULES AFTER CHOREOGRAPHY HAS BEEN COMPLETED, YOUR ACCOUNT WILL BE ASSESSED A \$500 RECHOREOGRAPHY/EARLY WITHRAWAL/DISMISSAL FEE.

PAYMENT METHODS

NEW THIS SEASON

IN ORDER TO STREAM LINE PAYMENTS, WE WOULD LIKE ALL PAYMENTS TO BE MADE THROUGH THE ONLINE PORTAL FOR REGISTRATION, TUITION AND OTHER FEES LISTED IN THE TEAM PRICING SCHEDULE.

WE UNDERSTAND SOME MAY NOT WANT TO PAY THE TRANSACTION FEES IN THE ONLINE PORTAL, SO YOU CAN PAY BY DEBIT CARD IN PORTAL WITHOUT ANY FEES OR BY CASH/CHECK AT THE GYM..

AS OF JULY 1, 2026, WE WILL NO LONGER ACCCEPT AMERICAN EXPRESS ,ZELLE OR VENMO FOR TUITION AND FEES. ZELLE AND VENMO WILL STILL BE ACCEPTED RIGHT NOW FOR PROSHOP ITEMS.

PLEASE MAKE ALL CHECKS PAYABLE TO : ONE ELITE (BE SURE TO INCLUDE YOUR CHILD'S NAME AND WHAT IT IS FOR ON CHECK MEMO LINE)

SICKNESS/INJURY/MEDICAL POLICY/INSURANCE

ALL ATHLETES MUST BE PHYSICALLY CAPABLE OF PERFORMING ALL THE ACTIVITIES OF THE TEAM DURING PRACTICE and COMPETITIONS. A CURRENT PHYSICAL MUST BE PROVIDED INDICATING YOUR CHILD HAS NO LIMITATIONS FOR PHYSICAL ACTIVITY.

IF YOUR CHILD SHOULD SUSTAIN ANY INJURY WITHIN OR OUTSIDE OF GYM YOU MUST PROVIDE A DOCTOR'S NOTE IN ORDER FOR YOUR CHILD TO BE EXCUSED FROM CERTAIN PHYSICAL ACTIVITY TEMPORARILY during practice.

DOCTOR'S NOTE'S ARE ALSO REQUIRED FOR MISSED PRACTICES DUE TO ILLNESS. ILLNESS TO MISS PRACTICE IS CONSIDERED ANYTHING WHICH CAN BE CONTAGIOUS SUCH AS FLU, COVID, FEVER, VOMITING, STREP, PINK EYE, ETC. BASIC COLDS WITH COGESTION, HEADACHES, COUGHS, EARACHES ARE NOT ACCEPTABLE REASONS TO MISS PRACTICE.

YOUR CHILD MUST HAVE MEDICAL COVERAGE TO REGISTER FOR THIS PROGRAM. ONE ELITE WILL NOT PUT A CLAIM INTO THEIR LIABILITY INSURANCE FOR MEDICAL EXPENSES TO COVER ATHLETE'S INSURANCE DEDUCTIBLES OR OUT OF POCKET EXPENSES DUE TO ACCIDENTAL/STANDARD SPORT INJURIES

If your child should sustain a temporary injury and cannot practice or compete, monthly tuition payments must still be made in order to hold her spot on the team. You understand there will be no refund for any fees for competitions missed during this time period since a fill-in will take the spot of my athlete and fees paid will be transferred to the fill-in so the team can continue to compete. If injury should put an athlete out for the remainder of season, then monthly payments would cease and account will be balanced to see if any remaining fees are due since our tuition is all inclusive of multiple services that your child might of received already. The fill-in will then assume the roll of a crossover athlete and pay remaining competition fees.

IF YOUR CHILD SHOULD SUSTAIN AN INJURY, MENTAL BLOCK OR ANYTHING ELSE WHICH SHOULD PREVENT HER FROM PERFORMING HER REQUIREMENTS IN THE ROUTINE, THEN ONE ELITE HAS THE SOLE DISCRETION TO REPLACE HER FOR A COMPETITION, INCLUDING THE SUMMIT. YOU UNDERSTAND ONE ELITE NEEDS TO DO WHAT IS BEST FOR THE TEAM.

TRAVEL/HOTEL POLICY FOR EVENTS

We do travel for most competitions, and they will require weekend overnight stays. There is Out of State travel required to 1-3 comps possibly for ELITE Youth/Junior/Senior teams. Full Season Prep teams (Youth or Junior) usually do not travel out of state, but always a possibility for 1 in Georgia, but we do try to avoid if we can. Tins and Minis do not travel out of state, but they do travel within the state. You are responsible for all travel expenses (airfare, hotel, food, and gas), along with spectator admission to the competitions for parents, family and friends.

Most competition companies require us (meaning "mandatory" in order for team to compete) to use their hotel booking agency for overnight stays or room blocks and we must abide by this, and you must book rooms only through them. There are some exceptions that can be requested such as using reward points or military discount.

For competitions that do not require this, but One Elite makes their own room block, then all cheerleaders will be required to stay in that block, unless the block has been filled or an exception has been approved by One Elite.

It is the parent's responsibility to reserve and pay for hotel rooms as well as supervise their children. There must be a parent in every room. Athletes must travel with a parent or another adult. Athletes do not travel with coaches or as a team. Parent or adult traveling with the athlete is responsible for their supervision. One Elite is not responsible for your child's safety during travel events.

ATTENDANCE/VACATION POLICY **SEE RULE #15 UNDER GYM RULES**

ALL PRACTICES ARE MANDATORY WITH THE EXCEPTION TO ILLNESS AS NOTED IN OUR ATTENDANCE POLICY AND SUMMER VACATION PLANS. ONCE SUMMER SCHOOL RECESS IS OVER AND SCHOOL BEGINS, **NO VACATIONS SHOULD BE PLANNED UNLESS PLANNED WHEN THE GYM IS CLOSED DURING THANKSGIVING AND WINTER RECESS(some years, not all we are closed for Pasco County spring break also).**SEE GYM CLOSURE DATES FOR THESE EXACT DATES.

WE ARE NOT CLOSED FOR SPRING BREAK EVERY YEAR. THIS IS DEPENDENT ON THE COMPETITION SCHEDULE WHICH IS FINALIZED IN AUGUST. IF WE DO CLOSE, WE WILL ONLY CLOSE FOR **PASCO COUNTY** SPRING BREAK. WE CAN NOT POSSIBLY CLOSE FOR EVERY COUNTY'S SPRING BREAK, SO IF YOUR SPRING BREAK IS DIFFERENT THAN PASCO COUNTY SPRING BREAK THEN YOUR CHILD WILL STILL HAVE PRACTICE DURING THEIR SPRING BREAK AND WILL BE REQUIRED TO BE THERE.

WE WILL SEND OUT A FORM LINK WITH TEAM PLACEMENTS TO BE FILLED OUT FOR ANY SUMMER VACATIONS. SUMMER VACATIONS WILL BE APPROVED AS LONG AS THEY ARE NOT DURING CHOREO WEEK AND NOT AFTER SCHOOL STARTS OR AUGUST 16..

**PRICE DISCLOSURE – UNFORTUNATELY, VARSITY HAS NOT RELEASED THEIR COMPETITION PRICING YET. WHILE WE DO NOT PREDICT TO HAVE ANY ADDITIONAL COSTS THEN WHAT IS LISTED ABOVE IN THE TEAM PRICING CHARTS AND ON COMPETITION SCHEDULE, THERE IS ALWAYS THE

POSSIBILITY OF AN ADDITIONAL UPCHARGE EXPENSE IF VARSITY SHOULD RAISE THEIR COMPETITION FEES BEYOND A REASONABLE AMOUNT. WITH THAT SAID, PRICES ARE SUBJECT TO CHANGE THEN.

All Registration and Monthly Payments are inclusive of the following:

- Registration which includes: One's Elite Gym Member Fee, Partial Choreo Fee, plus T-shirt
- All Competition Fees (**except those that have an extra upcharge as indicated on tentative comp. schedule attached**) –
 - Novice Teams (3-4 comps depending on comps picked)
 - Prep/Mini Elite Teams (4 comps, sometimes 5 depending on comps picked)
 - Elite YTH/JR/SR teams- (6-7 comps depending on comps picked)
- Bow and Makeup(Lipstick only-athletes can wear any neutral color eye shadow)
- ALL PRACTICES/TRAINING
 - Tinsys – 2 TO 2.5 hrs training per week (split into 2 days) and all addtl extra practices
 - Mini/Yth/Jr Prep and Mini Elite – 3 hrs training per week (split into 2 days) and all addtl extra practices
 - Elite Youth/JR/SR (all levels) – 4 hrs training per week (split into 2 days) and all addtl extra practices
- Second portion of Choreography Fees
- Competition Music (Professional)
- **MONTHLY TUITION FOR ALL TEAMS INCLUDES OPTIONAL TUMBLING CLASSES -current tumbling class days Tues, Wed, Thurs from 4:30-5:30 (specific levels on each day) and Friday (all levels-specific times).**

Monthly Tuition is the total cost of all of the above broken down into 11 payments (June thru April) and includes all training practices (even extra practices) from June 8 up to the last regular season competition which could be the first weekend of April, so you still pay your April payment for April is the last payment of the total cost and not necessarily for the month of April.

Summit Competition and Summit coaches training fee is not part of your regular monthly tuition payments(see Summit Notes below)

A Sibling Discount of \$50 per month will be given to any siblings on an Elite team(Yth/JR/SR) and will only apply to the monthly payments June thru April, not the Registration payment. Only \$25 sibling discount if the second sibling is on a Novice/ Prep/Mini Elite team.

Special Discount: One Elite supports Pasco County School employees (teachers and all staff), not private schools. We do offer a Pasco County School Employee Discount - \$25 off per month for 1st child, \$15 per month for second child or more from monthly tuition fees (excluding the registration fee). Please bring us copy of your Pasco school id to qualify for this discount.

(ONLY ONE DISCOUNT CAN BE APPLIED PER FAMILY ACCOUNT, the greater of the two will apply)

ADDITIONAL OUTSIDE MANDATORY EXPENSES

USASF Membership Fee (required to compete at Varsity events)– You will pay this directly to USASF once you renew or sign up. Directions will be provided at later date. Approx Cost is \$50 for season. **Please do not sign up for USASF or renew your membership until we tell you to.**

Cheer Shoes – For Elite and Prep teams, we use Nfinity or Rebel shoes, any style **except high tops**. You may purchase online at any site. Cost is approx. \$90-125. All girls must have their shoes by July 15th the latest, the earlier the better.

ONLY Novice/Exhibition teams can use any brand solid white cheer shoes as long as they have a flat sole, no ridges and brand logo is white, ex: NO black Nike swoosh.

One Elite Warmup Jacket – this is no longer mandatory

At this time, in order to keep cost down for families, we do not require mandatory warm-up jackets and pants, but anyone who feels the need to wear a jacket or pants on competition days must wear some kind of One Elite apparel that can be purchased in pro shop. Senior athletes whose uniforms have their stomach showing must always be covered up while at an event, except when competing.

SPONSORSHIPS -You may pursue individual sponsorships from local businesses which full amount received will go towards your account. Since we are not a non-for-profit business, businesses cannot write it off as a donation, but can write

it off as advertising since this is what we will offer them in exchange for sponsoring your child. A sponsorship form is at the end of this packet or can be picked up at the gym.

Competition Schedule

will be published by 8/15/26



The official Competition schedule will be published in the middle of August at the latest, but we are providing the below tentative list of competitions we will pick from. Competition costs are not finalized yet by event producers, so we cannot 100% finalize until we know the costs involved. This will at least give you a majority of the dates we are looking at. There could be others not on this list.

Not all teams will attend the same competitions. Mini Elite/Novice/Prep/Exhibition will not attend out of state competitions.

Novice Teams (3-4 comps), Prep Teams and Tiny/Mini Elite (4 comps, sometimes 5) and Elite YTH/JR/SR teams- (6-7 comps)-NUMBER OF COMPETITIONS ATTENDED ALL DEPENDS ON COST OF COMPS PICKED

GYM RULES

PLEASE REVIEW WITH YOUR CHILD THE GYM RULES/POLICIES BELOW. IF THERE IS AN INFRACTION TO ANY OF THESE RULES THERE IS CONSEQUENCES EVEN TO THE EXTENT OF POSSIBLE DISMISSAL FROM PROGRAM

1. **Apparel** - All One Elite Apparel and Accessories (hats, headbands, sunglasses, flip flops, water bottles, anything with our logo or name on it, etc) must be ordered thru gym and any team name apparel goods for spirit bags must be approved through the gym. No merchandise should be brought anywhere to be decorated with our logo or name. **Everything must come thru One Elite.**
2. All Spirit bag items will be discussed and approved with management before announcing to team parents. WE PLAN TO LIMIT OR POSSIBLY ELIMINATE THIS YEAR FOR THIS IS JUST AN ADDITIONAL EXPENSE PARENTS DO NOT NEED.
3. ABSOLUTELY No Jewelry during practice or competitions. **ALL PIERCINGS MUST BE REMOVED** and not covered with a band aid. IT IS A SEFTY HAZARD TO YOUR CHILD AND OTHERS. **WE WILL NOT PROVIDE BANDAIDS TO COVER PIERCINGS.**
4. **MEDICATIONS – WE WILL NOT DISPENSE ANY MEDICATIONS. WE WILL NO LONGER PROVIDE OR DISPENSE ADVIL/TYLENOL TO YOUR CHILDREN. IF YOU KNOW YOUR CHILD NEEDS ADVIL/TYLENOL FOR HEADACHES OR ANYTHING ELSE DURING PRACTICE THEN YOU MUST SEND IT WITH THEM.**
5. No long fingernails during practice or competitions. No nail polish during competitions.
6. Bloomers/sports bras must be worn by all females during practices.
7. No food or drinks(except water) allowed on the gym floor. **ABSOLUTELY NO GUM** allowed in Gym, ECSPECIALLY on Mats.
8. **No parents/family/friends/siblings are allowed on the floor/Tumble Trak during scheduled practices.** They must watch from the parent viewing area. All siblings must stay off equipment. Parents MUST NOT coach from side lines or yell onto the floor at their child or at coach while practices are in session.
9. No cells phone usage during practice unless to contact parent.
10. Practice attire – until you get your practice wear set, it should consist of black shorts, all black sports bra or tshirt, until you get your One Elite T-Shirt and practice wear. Hair should be up in a ponytail at all times during practice. Parents of younger athletes please make sure before you drop them off that they have their hair in a pony tail. We will not continue to provide pony tail holders every week.
11. Tumbling Classes/Private Lessons may only be done at One Elite, but you may attend summer camps/clinics/open gyms at other area gyms.
12. **Everyone must clean up after themselves & throw away any trash or empty water bottles.**
13. Timely arrival for practices and competitions as dictated by coaches. You will be considered Tardy if you are 3 minutes late to practice. Excessive tardiness can result in dismissal from the team.
14. Advise us of any weekend vacation plans in advance (at least 90 days before) so we can plan extra practices accordingly, especially during the holidays. One Elite might be open during certain school breaks and practices are required. Unfortunately, these breaks do fall within competition season. Please plan vacations when gym is closed.
15. **Attendance** is mandatory for all practices(INCLUDING EXTRA PRACTICES) and competitions. One member's absence has a negative impact on the rest of the team. Valid reasons for missing practices is Contagious Illness (fever/vomiting/strep,Covid, flu) and Death in family. In order for your absence to be excused you must have a doctor's note for illness or a funeral card for deaths in family.



ONE ELITE DETERMINES IF AN ABSENCE IS EXCUSED OR UNEXCUSED. ANY UNEXCUSED ABSENCE OR VACATION

REQUEST NOT APPROVED CAN RESULT IN DISMISSAL FROM THE PROGRAM. In other words, if it's not approved, they must be at practice. If they are not at practice, then unfortunately there are consequences for that choice which can be either suspension from a competition or dismissal from the team. The specific consequence will be at the discretion of One Elite owners.

Any unexcused practice (not approved) missed within two weeks of a competition does have serious consequences and will result in suspension from that competition or dismissal from their team.

All athletes will make One Elite a priority over other extracurricular activities. This means you may have to miss school events such as school cheer competitions, chorus concerts, powder-puff games, fall/spring school festivals, parties, and possibly other major events to be at practice and competitions, especially any two weeks prior to a competition or any extra practices which are called for on weekends.

*****IF YOUR CHILD IS ABSENT FROM PRACTICE AND IT IS A NO SHOW/NO CALL OR IF WE ARE LIED TO ABOUT WHY YOUR CHILD IS MISSING PRACTICE AND WE FIND OUT OTHER WISE, WILL RESULT IN SERIOUS CONSEQUENCES OF EITHER SUSPENSION FROM NEXT COMP or DISMISSAL FROM THEIR TEAM.**

Summer Vacations will only be allowed until school starts, with the exception of choreo dates. Once school starts any family vacations must be planned when the gym is closed or on weekends when we do not have extra practice. ATHLETES CAN NOT MISS A WHOLE WEEK OF PRACTICE FOR FAMILY VACATIONS ANYTIME BETWEEN AUG 17 AND MAY 14.

Excessive absences will result in dismissal from the program.

16. SCHOOL CHEER

One Elite does support school cheer and we do our best to work around the Football season of middle and high school sideline cheer, but this will vary depending on what team your child is placed on. If you are placed on a team whose practice days conflict with standard game days(middle school=Tues. JV=Thurs, Varsity=Fri.) then we will allow you to miss only half those practices(One Elite picks which practices you can miss for you are not the only one missing for school cheer so we need to plan accordingly). If your team's practice nights were placed on opposite day of your standard game day, then you cannot miss any practices for the games which are placed on different days than their standard game day. Some school coaches are flexible, some are not. Suggest you tell them in advance that you have conflicts with games.

We, however, DO NOT work around the basketball season games. Since this occurs at the same time as competition season, you are required to be at practice and not let your team down since this is a competitive team sport which parents do pay a lot of money for. Absenteeism does affect the performance results of a team. The same goes for ANY other school related activities/sports/band/chorus/orf/powder puff, etc.

If there are any conflicts between One Elite's competition/extra practice schedule and High School cheer competition schedule, you are required to be at One Elite's competition/extra practice. It is unfair to their One Elite team to not be the priority. With that said, if there is a conflict and a workable solution that the cheerleader can do both, we will work with the athlete as much as we can, but in some cases like an out of state competition or a bid competition there will not be much we can do. If an athlete misses a One Elite competition due to a high school competition for whatever reason they will be dismissed from the team. This includes booking last flights out that get cancelled and they can not arrive on time for their team to compete.



17. Any cheerleader found to be acting inappropriate, drinking, smoking/vaping, using or carrying drugs or alcohol, cheating, lying, stealing, using profane language or anything considered to be offensive or making inappropriate social media posts while at One Elite premises, at competitions or on social media will not be tolerated and may result in suspension from a competition,

dismissal from their team for the season or One Elite's program. This is also inclusive of Facebook, Instagram, twitter, snapchat, Tik Tok or any social media app as long as you are a member of One Elite and are representing our facility. We take this rule very seriously, esp. if you are portraying yourself in any One Elite apparel. This will also apply to parents and can cause dismissal of your child from their team or the gym, excluding the smoking of cigarettes and drinking(for parents)

18. All program members should set a positive example to others to follow. ALL team members and parents WILL BE RESPECTFUL AND COURTEOUS to each other. Please do not talk negatively about other children on your team or another team. One Elite will not tolerate any form of bullying. Any parent/child that causes disruptions, makes negative comments or in any way creates an atmosphere which is not positive will be asked to leave the gym. We welcome constructive criticism, but negative parents will not be tolerated. We prefer to surround our athletes and other parents with positive thinking people. Any offense could result in dismissal from program.
19. ALL team members and parents will show respect to all coaches/owners/parents during practices/competitions or any event/fundraiser. Any offense by athlete or parent could result in dismissal from program.
20. **All team and routine changes, including team level/division changes are at the discretion of the owners/coaches. Routine Changes and athlete spot changes may be made after every competition based on the judges' comments. There will be no arguing or questioning the coaching staff's decisions at the gym or at a competition. They will make changes based on what is best for the team and not your child for this is a TEAM sport.**
21. Please feel free to speak to your coach about anything, but at the appropriate time. Approaching a coach in middle of practice would not be considered an appropriate time. Feel free to schedule an appt. with coach/owners to discuss any issues.
22. All program members (athletes and parents) will refrain from any negative talk about the gym, staff, cheerleaders or other parents. This includes any posts on social media even if it is your personal page. So please watch what you post.
23. We support you in wanting to support and congratulate all internal gym teams and other gym's teams at competitions.
24. One Elite will place athletes on a team it feels will best suit them and the program. If at any time an athlete sustains any injury, mental block or anything which should prevent them from performing their requirements in the routine or from practicing the week before a competition, then One Elite has the right to replace them for any competition, including the Summit. One Elite needs to do what is best for the entire team.
25. **One Elite reserves the right to move any child to another team due to loss/gain of skills, ability to perform current level skills/stunts or even if just needed by One Elite to fill a specific spot on another team.**
26. Coaches have right to close practice at any time.
27. Any prize money earned at competitions will be used in the program at the discretion of One Elite Mgmt.
28. Athletes will accept team placements and awards with dignity and class.
29. All athletes must bring their own water to practice. We do not have a vending machine. We hope to be purchasing a beverage cooler soon to fill with water for purchase.
30. Uniforms for HALF SEASON teams are owned by One Elite. Uniforms may not be worn for any other reason, except for competitions or showcases. Any preventable damage to uniforms will be the responsibility of the athlete's parent for any financial cost for replacement. All other teams own their uniforms and leotards.
31. **One Elite has the right to remove, replace, add, suspend or dismiss any athlete from a team or the entire gym at any time during the season based on any infraction of the above rules or policies in our terms and conditions. This is inclusive of any of the following issues also: attendance, attitude, non-performance of skills, outstanding payments, or parent/athlete negativity/bullying/drama OR ANY UNACCEPTABLE PARENT/ATHLETE SOCIAL MEDIA POSTS. We take unacceptable social media posts seriously and will not tolerate it, whether you think there is nothing wrong with your post or your child's post.**
