



ACCREDITED MASTER'S PROGRAMS FOR TRAINING IN HEALTH SERVICE PSYCHOLOGY: 2025

This is the official listing of APA-accredited master's programs; it reflects all Commission on Accreditation (CoA) decisions made in 2025 through October 18, 2025. The listing of programs accredited in 2025 includes the program's name, program address, date of initial accreditation, current accreditation status, and next site visit year (if a fully accredited program). The next site visit year is not included for accredited, on contingency programs. A program that is accredited, on contingency must provide outcome data for trainees in the program and program graduates by the time two cohorts have completed the program. Program review is governed by the *Standards of Accreditation for Master's Programs in Health Service Psychology* (SoA-M). The CoA accepts third-party comment on programs in advance of their next scheduled review. Accreditation is a voluntary process. Programs that have not applied for and received accreditation are not included in the following list. Programs that have applied for initial accreditation but not yet received a decision are listed on the OPCA's [list of programs applying for initial accreditation](#). The accreditation status listed for each program is reflective of its status as of October 18, 2025. If a review of a program is not complete, the program's prior accreditation status continues to be in effect until the review has been completed and a final decision has been reached. Programs listed as accredited and accredited, on contingency have been judged by the CoA to be consistent substantively and procedurally with the SoA-M. Programs listed as "accredited – inactive" have been given this status as the programs are not admitting trainees during the listed year. Programs listed as "accredited, on probation" are, in the CoA's judgment, not currently consistent with all aspects of the SoA-M.
