- ¹ Doctoral programs granted Accredited on Contingency status are due to apply for full accreditation within a three-year time frame. See Implementing Regulation (IR) C-29 D.
- ² Inactive status is awarded to programs for the 2025-2026 training year that have submitted a phase out/closure plan or have not admitted students for the past two years. Programs granted this status are reviewed by the CoA on an annual basis. Dates listed are for the program's next site visit and are omitted if the program has a scheduled closure date preceding the next scheduled visit.
- ³ Whenever it is deemed appropriate, the CoA may defer making a decision about a program in order to obtain more information due to noncompliance with one or more standards. The deferral is effective on the last day of the program review meeting. The CoA will notify the program in writing and specify what additional information is needed and/or what concerns need to be addressed in order to determine the program's consistency with the SoA.
- ⁴ Internship programs granted Accredited on Contingency status are due to apply for full accreditation within a two-year time frame if the program is full-time (four years if a half-time program). See IR C-26 I.
- ⁵ Inactive status is awarded to programs that will not be accepting trainees for the 2025-2026 or 2026-2027 training year (as indicated). This status is granted by the CoA for one year at a time. The program will need to request for renewal of inactive status prior to the beginning of the next training year.
- ⁶ Summary of programs that have voluntarily withdrawn since the last Notice of Actions; individual notices have been sent for each withdrawn program.
