As our customer it is important that you understand the products and services available as well as the cost for each item you select. The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. *This facility is licensed & regulated by the Montana Board of Funeral Service, PO Box 200513 - 301 S. Embalming Disclosure

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose as arrangement that does not require you to pay for it, such as direct cremation or immediate burial. According to 37.116.103 Administrative Rules of Montana, a "body in route more than 8 hours, or if the termination of common carrier transport occurs more than 36 hours after the time of death, the body must be embalmed or refrigerated at 35 degrees F or colder," or "when being transported by a private conveyor and the body will not reach its destination within 48 hours after the time of death, must be either embalmed or refrigerated at 35 degrees F or colder."

Death Certificates

Death Certificates are filed with the state of Montana. Certified copies may be requested from any counties' Clerk and Recorder in the State of Montana and cost \$7 each.

Medical Examination – Law Enforcement Examination – Autopsy

When a medical examination or autopsy is being performed by a county coroners office our staff will communicate and coordinate with the office conducting the investigation. Our removal staff can only take possession of the deceased once the medical investigation is complete.

Body Donation and Procurement

This is not the same as Organ Donation (heart, lungs, liver, kidney, etc.)

Tissue donation, if your family so chooses is wonderful gift. However, Our staff has witnessed 2–18 hours between the time of death and the procurement team completing their operation and releasing the remains.

There will be visual side effects from the procurement process;

Viewing the deceased, post organ donation, is not possible without embalming and possible reconstructive procedures.

Still Born Child and Infant Policy

In the event of still-born, infant, or child's death (up to age one) our company will work with the Ramsey Keller Foundation to offer appropriate services at no cost to the family.

The cremation is scheduled at the earliest convenience of the family without any ceremony or gathering. It includes; transportation of your loved one up to 25 miles from Simple Cremation Montana, completion of paperwork from the doctor and coroner, the filing of Veteran's paperwork, submitting obituaries, finalizing insurance claims, and notification of Social Security, Disability, Medicaid and/or Medicare.

This offering does not include an urn, death certificates, viewing, embalming, or cemetery expenses

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). *Human remains delivered to a crematory may not be removed from the cremation container, and the cremation container must be cremated with the human remains. Montana Code Annotated 2021 37-19-705 (5)* A selection of cremation caskets we provide are listed on page 4. The fiberboard casket with no interior lining is offered with the Simple Cremation.

MEMORIAL SERVICE..... \$575

The funeral home staff assists in arranging a highly personal way of celebrating your loved one's life that reflects the uniqueness of the decedent. Often, personal memorabilia of your loved one is displayed and selected speakers share their own life memories and experiences of the decedent at Simple Cremation Montana or the venue of your choosing. The decedent is not present with cremation taking place before the ceremony.

GRAVESIDE SERVICE..... \$350

A graveside service is a personalized service at the final resting place, giving family and friends a final goodbye as your loved one is laid to rest. Often held alongside a memorial service, the graveside service offers a time for final words of farewell and can include speeches, eulogies, hymns, poems, and musicians may play.

ID VIEW FOR IMMEDIATE FAMILY ONLY..... \$325

No embalming or public visitation included. This is a private final goodbye for immediate family only to be held at our facility at the time of arrangements for no longer than one hour.

FORWARDING & RECEIVING HUMAN REMAINS

FORWARDING REMAINS to Another Funeral Home..... \$2395

Charges for forwarding of remains to another funeral home includes the basic service for funeral director and staff; transportation at the time of death; embalming (if required); consultation with responsible party; coordinating arrangements with receiving funeral home; preparing and filing of death certificate and necessary permits; dressing and casketing of the body as requested; transportation of the casket/container to the airport. *This does not include casket, shipping container, mileage, state filing fee, certified copies of the death certificate, or airline charges.*

RECEIVING REMAINS from Another Funeral Home..... \$2395

Charges for receiving remains from another funeral home includes the basic services of funeral director and staff in coordinating the details with the other funeral home, family and cemetery involved; transportation from the airport to our facility or directly to cemetery as requested; temporary housing of the body at our facility if needed. *This offering does not include cemetery charges, mileage, airline charges, viewing, or funeral services.*

ANATOMICAL DONATION to a Medical School..... \$1350

Charges for anatomical donation of the body to a medical school includes the basic service of funeral director and staff; refrigeration and housing of the deceased until acceptance by medical school; preparing and filing of the death certificate and necessary permits.

This does not include cremation, viewing, funeral ceremonies, state filing fee, or certified copies of the death certificate.

ITEMIZED SELECTIONS

Professional Services

BASIC SERVICES of Funeral Director and Staff..... \$2095

This fee is for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.) This charge includes, but is not limited to, availability of staff 24 hours a day, staff and facilities to respond to initial requests for services, consultation with responsible party to determine services desired, sheltering of deceased up to 72 hours, coordinating service plans with cemetery, crematory and/or other parties involved in final disposition of the deceased, filing of death certificate and obtaining permits with the Health Department, and filing social security notification and veteran's interment forms.

EMBALMING..... \$575

Except in certain special cases, embalming is not required by law. However, embalming may be necessary if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.
