

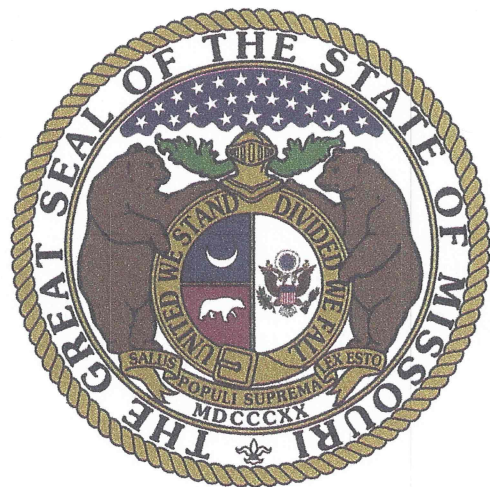



Article 6: The corporation shall not have members.

Any reference to Members or Membership in the Missouri State Statutes shall mean the voting Directors of the Board of Directors of the Foundation and not the Chapters, Regional Representatives, Corporate Members, or individuals other than the Directors elected pursuant to these Bylaws.

Article 7: In the event of the dissolution of the corporation, after paying or adequately providing for the debts and obligations of the corporation, all assets shall be distributed to a successor of the corporation. If a successor does not exist then to the Concerns of Police Survivors, Inc., as long as Concerns of Police Survivors, Inc. is in existence, is exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, and is managed by and operated under the direction of a volunteer board of directors. If the Concerns of Police Survivors, Inc. is not in existence, to an organization with similar purposes to the corporation or, if none, to one or more organizations with tax exempt status within the meaning of Section 501(c)(3) of the Internal Revenue Code. Upon inaction of the Board to adequately dispose of the assets upon dissolution, such assets shall be disposed of by the Judicial Circuit Court, or other court with competent jurisdiction, in the County in which the principal office of the corporation is then located to one or more organizations with tax exempt status within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding Section of any future federal tax code.

Article 8:

The purposes of the Foundation are:

1. Providing survivors of law enforcement suicide with peer support through various platforms.
2. Furthering the interests of communities, states, and the nation in matters relating to law enforcement officer suicide.
3. Collaborating with law enforcement agencies and survivors on navigating officer suicides and provide training relating to officer suicide.

The Foundation shall not advocate or support the pursuit of federal line of duty death compensation benefits or line of duty death recognition for law enforcement who die by suicide
