

Loveworks Kindness Rewards Draw – Terms & Conditions

1. Promoter

The promoter of this prize draw is Loveworks (“Loveworks”, “we”, “our”, “us”).

2. Eligibility

2.1 The prize draw is open to residents of the United Kingdom aged 18 years or over.

2.2 Employees, trustees, volunteers directly involved in administering the draw, and their immediate family members are not eligible to enter.

2.3 By entering this prize draw, entrants confirm that they are eligible to do so and agree to these Terms & Conditions.

3. How to Enter

3.1 To enter, participants must set up a new monthly donation to Loveworks via the designated donation platform between 1st June 2026 and 19th July 2026 inclusive (“Promotional Period”).

3.2 Existing supporters with an active monthly direct debit or recurring donation in place before the Promotional Period will automatically receive one entry into the draw.

3.3 Entrants must provide a valid email address when setting up their donation in order to be contacted if selected as the winner.

3.4 Entry allocation is as follows:

- Monthly donation of £5–£9.99 = 1 entry
- Monthly donation of £10–£19.99 = 2 entries
- Monthly donation of £20 or more = 5 entries

3.5 Only one recurring donation account per person will be eligible for entry, although qualifying donation amounts may generate multiple entries as outlined above.

3.6 No purchase other than the voluntary charitable donation is necessary to enter.

- 3.7 To remain eligible for the prize draw, entrants must maintain their monthly direct debit or recurring donation until the draw date. Any direct debit or recurring donation cancelled before the draw date will result in the associated entries being withdrawn from the prize draw.

4. The Prize

4.1 The winner will receive a “Weekend in Reigate” prize package made up of donated vouchers, experiences and gifts from participating local businesses.

4.2 The prize package may include, but is not limited to:

5.3 The winner will be notified by email within 7 days of the draw date.

5.4 If the winner does not respond within 14 days of notification, Loveworks reserves the right to select an alternative winner.

6. Publicity

6.1 By accepting the prize, the winner agrees that Loveworks may use their first name and general location for reasonable promotional purposes related to the campaign, unless the winner requests otherwise.

7. Data Protection

7.1 Personal data supplied during the course of this promotion will only be processed in accordance with applicable UK data protection legislation and Loveworks' privacy policy.

7.2 Personal information will be used for the administration of the prize draw and management of donations.

7.3 Entrants may opt in separately to receive future communications from Loveworks.

8. Cancellation and Changes

8.1 Loveworks reserves the right to amend, suspend or cancel the promotion where necessary due to circumstances beyond its reasonable control.

9. Liability

9.1 Loveworks accepts no responsibility for entries not successfully completed due to technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind.

9.2 To the fullest extent permitted by law, Loveworks shall not be liable for any loss, damage or injury suffered by any entrant arising from the promotion or acceptance of the prize.
