Effective September 2026

All KCDS group class fees are based on 40 teaching weeks per academic year. The annual cost of tuition is divided equally across 12 monthly Direct Debit payments, providing families with a consistent monthly payment throughout the year.

VAT

KCDS is VAT registered. All prices shown are inclusive of VAT where applicable, unless otherwise stated.

ACRO UPDATE - SEPTEMBER

From September, our current 1 hour 45 minute Acro session will be split into two classes:

Body Conditioning - 45 mins

£9.65 per lesson / £32.17 per month

Acro - 60 mins

£10.75 per lesson / £35.83 per month

All Acro students must attend Body Conditioning alongside Acro – the conditioning element is an essential part of their Acro training, so Acro cannot be taken on its own.

However, Body Conditioning can be taken as a standalone class and is open to other KCDS students who would like to improve their strength, flexibility and control.

MONTHLY DIRECT DEBITS - HOW IT WORKS

All regular KCDS class fees are paid monthly in advance by Direct Debit.

Your child's fees are calculated across our 40-week teaching year. The total annual cost is then divided equally across 12 monthly payments.

This means you pay the same amount each month, regardless of how many teaching weeks fall within that particular calendar month.

For example, one month may contain five lessons while another may include school holidays and contain fewer or no lessons. Your Direct Debit remains the same because each payment is an equal instalment towards the total annual cost of your child's 40 weeks of tuition.

FIRST PAYMENT

When joining a class at KCDS, your first payment will include two months' fees:

- Your first month's class fees
- One month's fees held to cover your notice period

After this initial payment, your Direct Debit will return to the normal monthly amount.

The additional month's payment is not an additional class fee. It is held on your account and used towards your final month's fees when the required notice is given.

LEAVING A CLASS

KCDS operates a one-month notice period.

Written notice must be given to the KCDS office if your child wishes to leave a class. The month's fees held on your account will then be applied to the notice period/final month. Cancelling your Direct Debit does not constitute notice and may result in an outstanding balance being due.

KCDS MEMBERSHIP

A £5.00 membership fee + VAT (£6.00 including VAT) per student, per term will be added to your invoice three times during the academic year.

Autumn Term – £6.00 including VAT

Spring Term – £6.00 including VAT

Summer Term – £6.00 including VAT

Total annual membership: £18.00 per student including VAT.

MINIMUM CLASS SIZE

Group classes require a minimum of 8 students to run at the standard advertised rate.

Where numbers fall below this threshold, we may offer families the option for the class to continue at an adjusted rate. Any proposed change will be communicated before being applied.

Private coaching is charged separately and is not included within the 40-week monthly class fee structure.

HOW TO BOOK PRIVATE LESSONS

Teachers will advertise available private coaching sessions on the relevant KCDS Facebook page/group and Instagram Page.

Performance Team and competition private lesson availability will also be advertised within the KCDS Performance Team Facebook group.

Booking Process

1. Add your child's name to the teacher's Facebook post if you would like a private lesson.
2. The teacher will create a schedule based on the students requesting lessons, teacher availability and available studio time.
3. Wait for teacher confirmation. Once the teacher has liked your child's name/comment, a private lesson slot has been allocated.
4. Book and pay through Acuity - <https://www.katiecoxdancestudio.com/private-lessons> Once your slot has been confirmed by the teacher, please complete the booking and payment through Acuity. Please do not book through Acuity until the teacher has confirmed your slot.

In Simple Terms

Facebook → Request your private

Teacher likes/confirms → Slot allocated

Acuity → Book & pay

PRIVATE LESSON CANCELLATION POLICY

A minimum of 48 hours' notice is required to cancel or reschedule a private lesson.

With more than 48 hours' notice, the lesson may be rescheduled subject to availability, or the payment carried forward to a future booking.

Cancellations made with less than 48 hours' notice are non-refundable and cannot be rescheduled.

Failure to attend a booked lesson without notice will be treated as a late cancellation and is non-refundable.

If a KCDS teacher has to cancel, an alternative appointment will be offered. If this is not possible, a full refund or credit will be provided.

ADDITIONAL CHARGES

Show Fee – TBC

Includes show administration, additional rehearsals.

Examination Fees

RAD and ISTD examination fees are charged separately. Additional charges may apply for exam coaching, mock exams and exam-day costs.

KCDS Membership – £6 per term / £18 per academic year

IMPORTANT
