**TOWALIGA CIRCUIT CHIEF ASSISTANT DISTRICT ATTORNEY DOROTHY HULL
ANNOUNCES CAMPAIGN FOR DISTRICT ATTORNEY**

A Seasoned Prosecutor Ready to Continue Keeping Our Families Safe

Today, Dorothy Hull, the Chief Assistant District Attorney for the Towaliga Judicial Circuit, announced that she will run for District Attorney. Current District Attorney Jonathan Adams has announced that he is running for Superior Court Judge. The Towaliga Judicial Circuit covers Butts, Lamar, and Monroe Counties.

Hull is a seasoned prosecutor who has spent nearly three decades prosecuting violent felonies. She has specialized in child victim crimes and has worked relentlessly to bring those who abuse and prey on children to justice. Hull has also prosecuted numerous murder cases and has argued many cases in front of the Georgia Court of Appeals and the Georgia Supreme Court.

Said Hull, "I have devoted my career to holding violent offenders and some of the worst in our society accountable, to securing justice for victims, and to keeping our families and communities safe. I am ready to continue doing the same as your next District Attorney. I will bring my proven experience and relentless commitment to justice and public safety to the job to continue the proven track record of the Towaliga District Attorney's Office."

The people of Butts, Lamar, and Monroe Counties can rest assured that I will never waver when it comes to doing what is necessary to prosecute dangerous criminals under the law to keep them off our streets. More About Dorothy Hull

Towaliga Circuit Chief Assistant District Attorney Dorothy Vinson Hull graduated from University of South Carolina School of Law in May 1996, after having graduated Magna Cum Laude with a Bachelor of Arts Degree from Georgia College in Milledgeville in 1993.

After law school, Ms. Hull worked as a law clerk for the Superior Court Judges of the Ocmulgee Circuit until April 1997 when she was hired as an assistant district attorney in the Macon Judicial Circuit.

In the Macon Circuit, Ms. Hull spent twenty-four years prosecuting violent felonies including murder, aggravated assault, child molestation, rape, and sexual assault. Specializing in child victim crimes, Ms. Hull worked closely with law enforcement and the child advocacy center to assist child victims and prosecute offenders who abused and preyed on children.

Ms. Hull has spent her career prosecuting sexual and child abuse cases and has worked with law enforcement and expert witnesses to present the cases in a persuasive manner to juries. In addition to this specialized area of the law, Ms. Hull has prosecuted many murder cases in both Bibb County and in the Towaliga Circuit.

Ms. Hull's prosecution experience includes appellate work, and she was head of the appellate division for the Macon Judicial Circuit from 2012 until her retirement in 2021. Ms. Hull argued many cases in the Court of Appeals and Supreme Court of Georgia on behalf of the State.

In 2021, Ms. Hull became a prosecutor in the Towaliga Judicial Circuit where she is head of the appellate division and handles a variety of criminal cases including child molestation, murder, felony traffic, and gun crimes.

Ms. Hull lives in Monroe County with her husband, Chief Deputy Mike Hull with the Monroe County Sheriff's Office, and their children, Katherine and Benton Hull who are students in Monroe County Public Schools.
