• A huge <u>WIN</u> for June is that the Recreational and Creative Arts Therapists positions for the Veterans Administration (VA) have been included on the VA Approved Exempt from Hiring Freeze list. Thank you to all who wrote letters, made calls, or reached out to your legislators to advocate for recreational therapy at the VA! This is amazing and shows how we as a profession can work together to make a difference for the populations we serve and for recreational therapists.

Legislative Update

• In June, legislative activity in Washington, DC focused on the Budget Reconciliation bill (the Big Beautiful Bill) as it worked its way through the U.S. House of Representatives and then the U.S. Senate; in early July, it went back to the House, where it was passed and signed by President Trump into law.
