#### Introduction

ATRA's advocacy activities are focused on bills, actions, or issues that directly impact the profession of recreational therapy or people with disabilities. ATRA responds to issues in a non-partisan manner to advocate and protect the recreational therapy profession and people served by recreational therapists.

In September, there has been limited Congressional activity. The House of Representatives has not returned to DC but is expected back in early October. Various agencies have been active with other actions and initiatives.
