Re: Support for Full Funding of NIH Rehabilitation and Disability Research in FY 2027

Dear Chairs Moore Capito and Aderholt and Ranking Members Baldwin and DeLauro:

On behalf of the disability and rehabilitation research community, the undersigned individuals, organizations and institutions urge you to strongly support full funding for medical rehabilitation and disability-related research at the National Institutes of Health (NIH). In particular, ***we are requesting continued and robust funding for the National Center for Medical Rehabilitation Research (NCMRR)*** within the Eunice Kennedy Shriver National Institute of Child Health and Human Development (NICHD), in the FY 2027 Labor, Health and Human Services, Education, and Related Agencies Appropriations bill.

NCMRR supports approximately \$90 million in rehabilitation science annually and is statutorily designated as the agency within NIH to coordinate over \$900 million in rehabilitation and disability research conducted and supported across many of the NIH's 27 Institutes and Centers. Unlike many other NIH Institutes and Centers, the NCMRR does not receive a direct appropriation from Congress; instead, its funding is allocated as a percentage of the overall budget of NICHD. As such, we do not request a specific funding level for NICHD and NCMRR, but urge Congress to fully fund these important research agencies.

NCMRR and other NIH institutes and centers support biomedical and engineering research aimed at improving function, rehabilitation outcomes, and quality of life for individuals with disabilities due to injury, illness, or congenital conditions. Its portfolio includes critical work on stroke recovery, spinal cord injury, traumatic brain injury, developmental and neuromuscular disorders, limb loss, and many other disabling conditions. NCMRR plays a key leadership role within NIH by coordinating rehabilitation science across institutes and fostering innovation in a way that maximizes the return on the federal investment in rehabilitation and disability science.

To strengthen coordination of rehabilitation science and disability research priorities across institutes, we urge the NIH to prioritize and implement the newly-published ***NIH Disability Health and Health Care Research Plan***. We are grateful the NIH issued this important strategic framework which marks a long-overdue commitment to addressing the comprehensive needs of people with disabilities and embedding disability health research issues across the NIH portfolio. The plan outlines actions to enhance data collection, support scientists with disabilities, promote study designs relevant to disability populations, and ensure that the needs of people with disabilities are identified and visible in the nation's health research agenda. ***We urge Congress to dedicate additional resources within the NIH Office of the Director to ensure effective implementation, including the establishment of a centralized disability research office to sustain cross-agency leadership and accountability.***

Thank you for your leadership and for your continued support of policies and programs that advance health, function, and opportunity for people with disabilities. We look forward to continuing to work with you to ensure that medical rehabilitation and disability research remains a national priority in FY 2027 and beyond.
