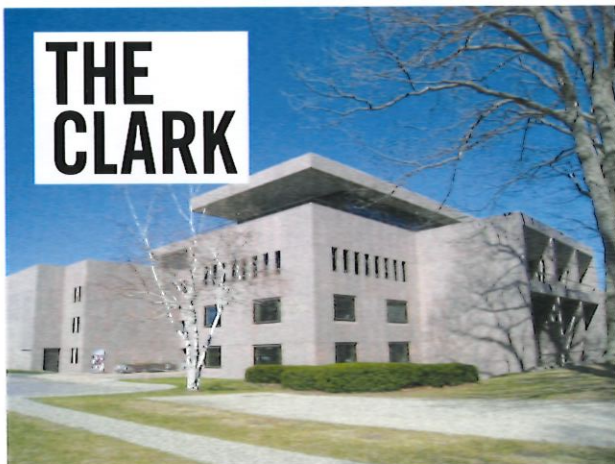

WEDNESDAY, JULY 22 - DAY 1

- * We will depart from the Lewes, Delaware for Lenox, Massachusetts making rest stops and a lunch stop on your own en route. Welcome to the Berkshires! Serene mountain vistas, lush forests and clear blue lakes define the landscape of this famous western Massachusetts region. Upon arrival we will check in to the lovely **Hampton Inn, Lenox, MA**. Take time to freshen up after our long ride.
- * Tonight, **dinner is included** at a Berkshire area Restaurant.

THURSDAY, JULY 23 - DAY 2

- * Each morning an **Expanded Continental Breakfast with Hot Choices** is served inside our hotel.
- * This morning we'll travel to the **Berkshire Botanical Gardens**, a 24-acre botanical garden in Stockbridge, MA. We will enjoy a **guided tour through the garden collections** containing over 3,000 species and varieties, with an emphasis on plants that thrive in the Berkshires.
- * Our next stop brings us to "**The Mount**", the **country home of American author Edith Wharton**. Wharton designed the house and its grounds and considered it her "first real home". We will enjoy a **guided tour of the home** followed by a delicious **picnic buffet lunch** served on the terrace. Following lunch we will have a little time to continue exploring the grounds and gift shop.
- * We will now make our way to historic downtown **Lenox, MA** for shopping and free time before heading out to **Hilltop Orchards** for a tour and tasting of Craft Ciders and Wines.
- * **Dinner is included** this evening at another Berkshire area restaurant.

FRIDAY, JULY 24 - DAY 3

- * Following breakfast we will make our way north to Williamstown, MA
- * Visit the **Sterling and Francine Clark Art Institute**. The vast collection includes European and American paintings, sculptures, drawings, photographs and decorative arts. Lunch will be on your own today at the museum.
- * This afternoon we will take in a performance at the **Williamstown Theater Festival** OR have an evening performance at **Jacob's Pillow**. (The performance we attend will depend on the release of the 2026 schedules- neither venue has released their dates for next year)
- * Dinner will be on your own this evening.

SATURDAY, JULY 25 - DAY 4

- * Following breakfast this morning we will make our way to **Tanglewood**, the summer home of the Boston Symphony Orchestra.
- * We'll take a **guided tour of the grounds and buildings at Tanglewood** before taking in a **Musical Performance**.
- * Following the performance we will journey to downtown Stockbridge, MA for lunch and shopping time on your own.
- * This afternoon we will visit the **Norman Rockwell Museum**, where we take in the largest and most significant collection of Rockwell's work.
- * **Dinner is included** this evening at a local restaurant.

SUNDAY, JULY 26 - DAY 5

- * After breakfast this morning it will be time to check out of our rooms and say goodbye to the Berkshires.
- * We will begin our journey home making a stop at the **Old Rhinebeck Aerodrome**, located in Red Hook, NY. The Aerodrome owns many examples of airworthy aircraft of the pioneer era, World War I and the Golden age of Aviation between the World Wars and multiple examples of roadworthy antique automobiles.
- * Lunch will be on your own today in Rhinebeck. We should arrive by early evening in Lewes, DE.

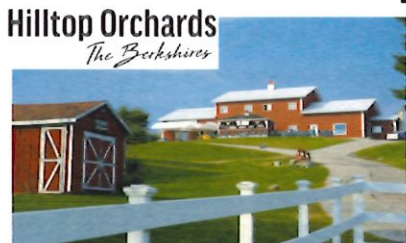

Trip cancellation & trip interruption

Protect travel investments and recover nonrefundable prepaid costs if your trip is canceled or interrupted for a covered reason. Popular covered reasons include:

- Sickness, injury, or death¹
- Residence or destination uninhabitable
- Strike
- Inclement weather
- Cancel for business reasons
- Traffic accident en route
- Quarantine
- Jury duty/subpoena
- Military duty
- Financial insolvency²
- Terrorist incident
- Theft of passport/visa
- Involuntary termination

Travel delay

Reimbursement for reasonable additional costs — such as accommodations, local transportation, and meals — if travel is delayed five hours or longer.

Baggage & personal effects

Reimbursement for personal articles and expenses if bags are lost, stolen, or damaged.

Baggage delay

Reimbursement for reasonable additional personal articles and expenses if bags are delayed for 12 hours or more.

Emergency medical & dental expenses⁶

Emergency medical treatment if sickness or injury occurs while traveling.

Emergency medical evacuation

Includes emergency medical evacuation to the nearest suitable medical facility, help returning home if medically necessary, and repatriation expenses.

Accidental death & dismemberment

Reimbursement for permanent loss of life, limbs, or sight from a covered accidental injury during travel.

Pre-existing medical condition exclusion waiver³
