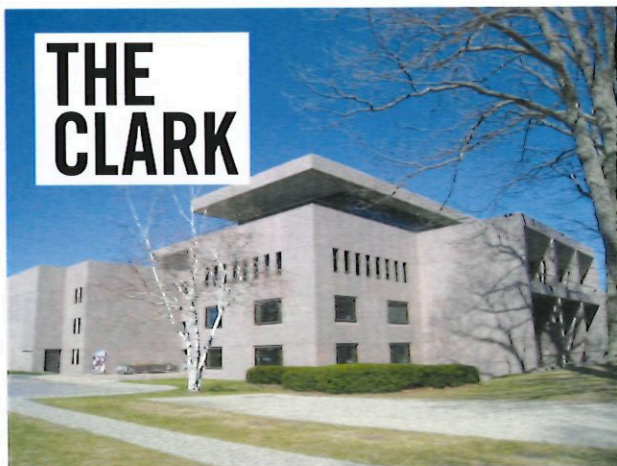

### Trip cancellation & trip interruption
