

MONDAY, OCTOBER 5 - DAY 1

- * We will depart from Lewes, Delaware heading north up to the beautiful Finger Lakes Region of New York State. From wine to waterfalls and world class museums, there are adventures and hidden gems around every corner of the Finger Lakes Region. Our first stop will be the **FINGER LAKES WELCOME CENTER** where there is a beautiful view of Seneca Lake, interesting exhibits and of course a **WINE TASTING OF (5) WINES!** Later this afternoon we'll check in to our home for the next 4 nights, the **HAMPTON INN, VICTOR, NY**
- * A mouth-watering **ITALIAN DINNER BUFFET** awaits us this evening at **OTTO TOMOTTOS**.

TUESDAY, OCTOBER 6 - DAY 2

- * Wake up each morning to an **Expanded Continental Breakfast with Hot Choices** at the Hampton Inn.
- * This morning we tour **SONNENBERG GARDENS & MANSION**. Built in 1887, the 40-room mansion offers a glimpse of what life was like in the late 19th century. The estate boasts 9 formal gardens representing many cultures and historic periods. (A tram is available to assist guests up hill to the mansion with mobility issues).
- * Lunch will be on your own today in the large food court at the Wegman's Market.
- * After lunch we will depart for Rochester, NY for a guided tour of the beautiful **EASTMAN MUSEUM** which is located on the estate of George Eastman, pioneer of popular photography and motion picture film. Take a tour of the historic mansion and gardens.
- * Our final stop this afternoon will be the popular **CASA LARGA VINEYARDS** for a tour and wine tasting.
- * Following our tour we'll depart for an included dinner at a local restaurant.

WEDNESDAY, OCTOBER 7 - DAY 3

- * Enjoy **Breakfast** at our hotel before we depart.
- * This morning we'll arrive for a driving tour of **LETCHWORTH STATE PARK**. Renowned as the "Grand Canyon of the East", it is one of the most scenically magnificent areas in the Eastern United States. Letchworth State Park was awarded the **#1 Best State Park in the USA by the USA Today 10 Best Readers' Choice Awards in May of 2025**. Our guide will take us through several picture-taking stops with breathtaking views and also give us some very interesting park history.

- * Today we'll stop by "TOM WAHL'S" for lunch on your own at this popular neighborhood eatery.
- * After lunch we will depart for Packett's Landing and arrive for boarding on the **COLONIAL BELLE**. Sit back and relax on a **3-HOUR ERIE CANAL CRUISE** that travels through the fascinating locks. See historic homes, several engineering feats and experience the locks as we pass through one of the 57 barriers that level the water by 566 feet from the mighty Hudson to Lake Erie.
- * Dinner is included tonight at an area restaurant.

THURSDAY, OCTOBER 8 - DAY 4

- * **Breakfast** is served at our hotel.
- * This morning we'll depart for the **SEWARD HOUSE MUSEUM & EQUAL RIGHTS HERITAGE CENTER**. The Seward House Museum is the historic home of William Henry Seward and his family. Seward served as a New York State Senator, Governor of New York, a U.S. Senator and as Secretary of State in the Lincoln and Johnson Administrations. The Equal Rights Heritage Center features a state-of-the-art exhibition titled "Seeing Equal Rights in NYS".
- * Enjoy lunch on your own today in the charming village of Skaneateles, NY.
- * This afternoon climb aboard the **JUDGE BEN WILES** cruise boat. Glide across picturesque Lake Skaneateles and see the homes of the rich and famous (including the summer home of Bill & Hillary Clinton).
- * Our final stop today is the **WILLARD CHAPEL**. Built in the 1890's entirely by the Tiffany Glass and Decorating Company of New York City, Willard Chapel is the only complete and unaltered Tiffany chapel known to exist.
- * Dinner is served this evening in the special ambience of the **SPRINGSIDE INN**.
