Some Ways to Make a Planned Gift:

General Bequests

A general bequest is one of the most popular ways to make a gift through your will or revocable trust. You simply designate the Lewes Senior Activity Senior Center to receive a specific dollar amount or a percentage of your estate.

Specific Bequests

With this type of bequest, you designate that the Lewes Senior Activity Center receives a specific asset from your estate. Such specific assets can include stocks, real estate, or other tangible personal property.

Life Insurance

You can donate the cash value of a policy or designate the Lewes Senior Activity Center as a beneficiary. You can also purchase a new policy and name the Lewes Senior Activity Center as the owner and beneficiary.

Set up a one-time or monthly contribution to the Lewes Senior Activity Center to remember someone special in a special way.
