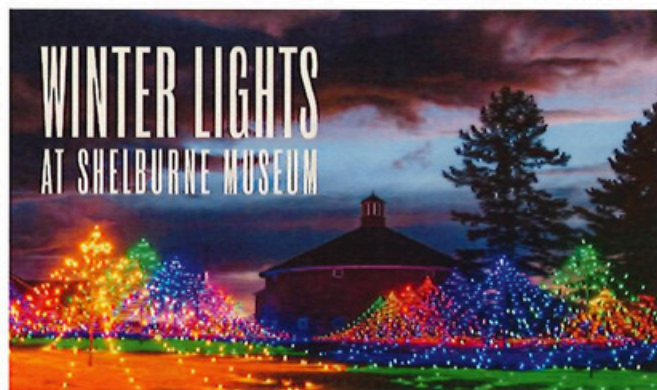

SUNDAY, DAY 1 - NOVEMBER 15

6:30am - Depart for Stowe, Vermont making rest stops and a lunch stop on your own along the way.

6:00pm - Arrive at the **von Trapp Family Lodge** for 4 magical evenings! As you enter the main doors of the von Trapp Lodge, you will be struck by a feeling of Christmas that might take your breath away. The lodge is decorated to the "Christmas Nines" in true Austrian fashion.

7:00pm - After you unpack, make your way to the dining room for a **traditional Christmas dinner and some good old fashioned caroling**. If the night still feels young, join the pianist in the lounge until 8:30 PM.

MONDAY, DAY 2 - NOVEMBER 16

7:00am - Wake up to a **hot breakfast** at the lodge.

9:00am - Time to meet our von Trapp Lodge guide in the lobby for a **von Trapp Lodge History Tour**. The hills are alive...you know the rest...tour the famed lodge where the von Trapp family made their home after leaving their beloved Austria during World War II. The tour begins with an overview of the family history - actual vs. movie version, then a discussion of the property's history and the family's early years in America. View a documentary film of Maria von Trapp's memories during her final visit to her former home in Salzburg, Austria. When possible, a von Trapp family member hosts a question and answer session.

10:30am - Meet our local guide in the lobby and head out.

11:45am - Enjoy the **Burlington, Vermont "street mall"** with no cars and many unique one-of-a-kind places to eat and shop. If the weather is right, the buskers will be out.

2:30pm - Stop at a well-loved artisanal **Chocolate Store** for a **tasting**.

4:30pm - Enjoy a **Beer Tasting** at one of the local micro-breweries. **6:00pm** - Dinner is included this evening.

TUESDAY, DAY 3 - NOVEMBER 17

7:00am - Enjoy the **hot breakfast** this morning at the lodge.

9:00am - Stop at the **Cider Mill**. This is a quick stop at a Vermont legend since 1974; the mill is now New England's largest producer of apple cider. Learn about cider making and enjoy samples of cider and other VT products. Wait until you see them make cider doughnuts and then taste one hot out of the oven!

10:30am - Each guest may now choose one of the following activities: (a) Visit a family owned and operated nursery and watch as a **hand-made wreath is created from scratch right before your eyes and leave with a complimentary gift**. OR (b) **Learn to make a holiday food gift and watch a demo on ways to present it**. Hot Chocolate with homemade marshmallows (enjoy tasting as well!)

11:45am - Lunch on your own in the historic district of Waterbury, Vermont.

1:45pm - Next we'll **learn about Dog Sledding**: Discover the joy Siberian huskies bring at your "Sled Dog Meet and Greet" where you can interact, pet and take photos with these adorable pups. This is your chance to find out what it takes to be a sled dog. You will get to experience the bond between humans and these amazing working dogs firsthand!

3:15pm - Factory tour and ice cream sample at **Ben & Jerry's**.

4:30pm - Return to the von Trapp Lodge and enjoy a yummy treat of **cookies and tea!**

4:45pm - At this time, our group will break into smaller sizes and

take part in a **Gingerbread House Workshop**.

6:00pm - Dinner is included this evening followed by a **traditional Yankee Swap**.

10:00am - Visit the famous **Vermont Teddy Bear Factory** and learn how a bear is made and repaired during a tour that will make you smile from start to finish.

1:30pm - Step through the doors and be transported to **The Village at Christmastime**. Visit the animated shops of the village and see the treasures that each shop holds.
