Annual Revenue:

- The \$5,000 Contributing Investor level is preferred for businesses that have over \$1 Million but less than \$3 Million in Annual Revenue.
- The \$7,500 Prestigious Investor level is preferred for businesses that have over \$5 Million in Annual Revenue.
- The \$12,000 Power Investor level is preferred for businesses that have over \$5 Million in Annual Revenue and a custom Membership Partnership Proposal.
- The \$25,000 Premier Investor level is preferred for businesses that have over \$10 Million in Annual Revenue and a custom Membership Partnership Proposal.
