MESSAGE FROM OUR 2019 PRESIDENT

The mission of the Broomfield Community Foundation has always been to strengthen the philanthropic activities of our businesses and citizens for the betterment of Broomfield. 2019 was another year of continuing growth and impact. This was most evident in the transition of "Dancing with the Broomfield Stars" to a shared event with nine local nonprofit partners. As a result of this collaboration, proceeds from the Dance provided over \$56,000 in grants for the nine partners and helped the Foundation support 56 additional grants for \$123,000; together generating more than any other "Dancing With the Broomfield Stars" event. These grants, along with scholarships and Donor Advised Fund distributions allowed your Foundation to contribute more than \$230,000 to the community in 2019; more than any prior year's distribution! Despite this growth, we are only able to meet about 60% of the financial needs of our grant requests. You can help overcome this shortfall in simple ways; such as joining iGive365 or our Legacy Fund as mentioned below.

We honored ten of our community members and the work they do within the community at our 19th Heart of Broomfield Award event in March. As always, these are people that impact individuals and organizations; truly providing the "heart" of Broomfield. Without these 10 and the more than 100 prior recipients, Broomfield would not be the special place it is. We believe this event is important to recognize these philanthropists and encourage new individuals to join the ranks of our non-profit organizations.

To support the non-profits in the community, we continued and expanded the Foundation's Knowledge Series, providing organizational and management skill support at no cost to any organization that wanted to attend. The series has presented taxation and donation strategies, building a strong board, teaching board skills to interested individuals and held our first ever speed networking event to introduce local nonprofits to citizens interested in finding an organization to join. This series continues to be well received by our nonprofits and citizens looking for organizations that match their passion.

During the year, two areas of interest became critically important to our citizens and the city at large. These needs spurred the creation of our "Broomfield Housing Fund" to support affordable housing efforts and our unhoused population, as well as the "Health & Wellness Fund" to support mental health initiatives and providers in alignment with the City's Community Health Improvement Plan. If these are areas of interest for you, I encourage you to donate to these funds, assured that your contributions will address the highest priorities to support people whose housing is insecure and those suffering debilitating mental health issues.

For the Foundation to meet the needs of the community, we established the iGIVE365 program and continued to grow the membership during 2019. Membership is simple and the impact is remarkable; visit www.iGIVE365.com where you can join for a minimum of \$30/month (only \$1/day). 100% of the funds donated to "IGive365" are granted each year, and as membership increases, we meet more critical community needs. In fact, if we had 750 members, we could fund 100% of our grant requests. Please help us grow to 750 by joining today!

Our Legacy Fund is critical to endowing future grants to the community and we have 40 members of this group. Our goal is to have the Legacy Fund reach \$2 million by 2020. If you can help us reach this balance, the Foundation would have an additional \$100,000/ year funding source to directly address critical needs, funded forever into the future. Please consider joining this distinguished philanthropic group by giving \$100 or more each month.




