Dear Community Members,

Thanks to your generosity, the Broomfield Community Foundation (BCF) has been committed to strengthening our community. Together, we've distributed over \$6.5 million to support essential programs and services in Broomfield. In 2024 alone, we granted \$668,017 to 76 local nonprofits and students, focusing on Human Services, Education, Seniors, Arts, and Civic initiatives. An increase of \$137,213 over 2023 due to our expanded partnership with the City and County of Broomfield!

We are grateful for the dedication of our Board, staff, donors, and community partners. Your support helps build a more vibrant Broomfield today and for future generations.

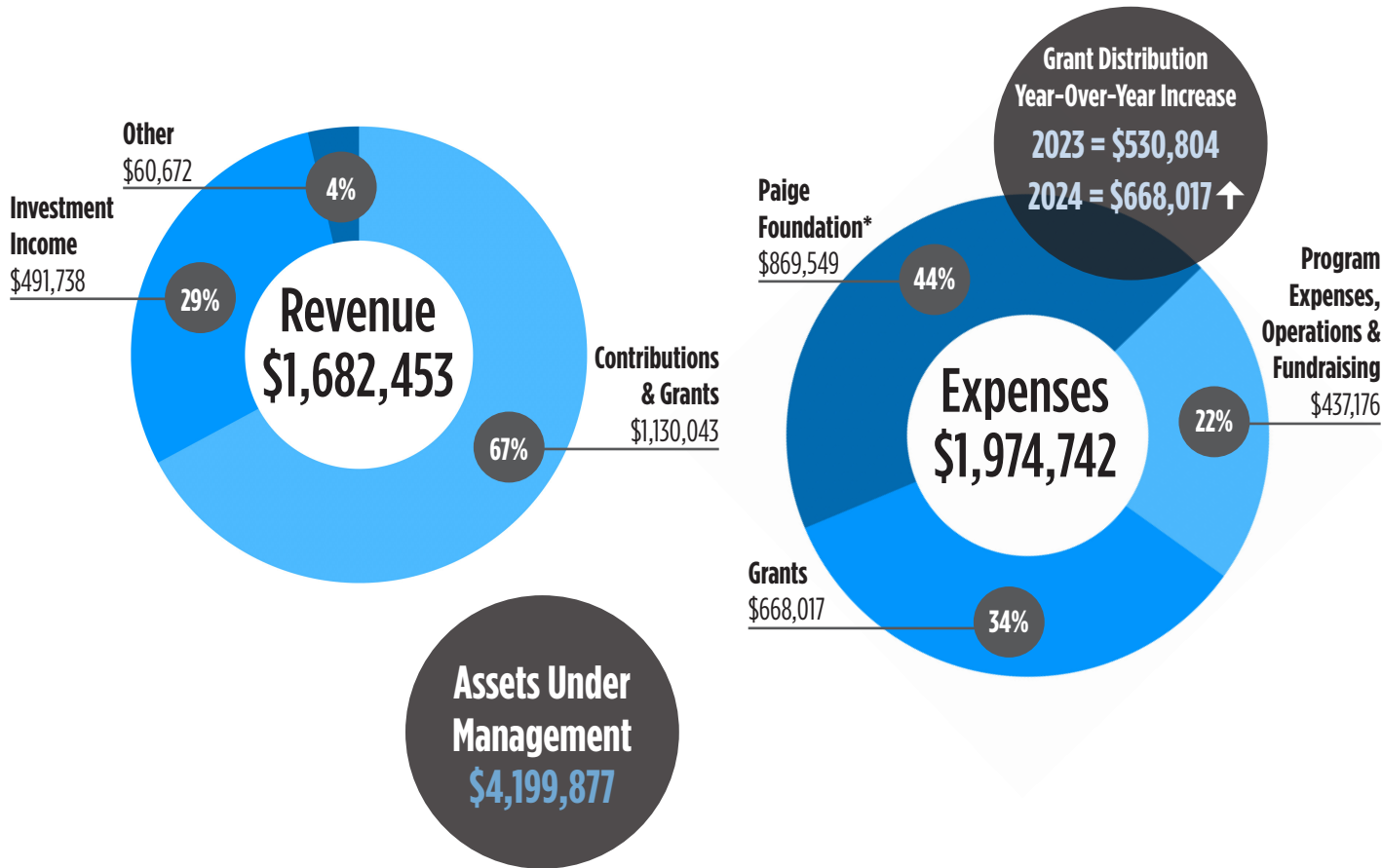

The Broomfield Community Foundation remains steadfast in its mission to support our community through strategic grantmaking.

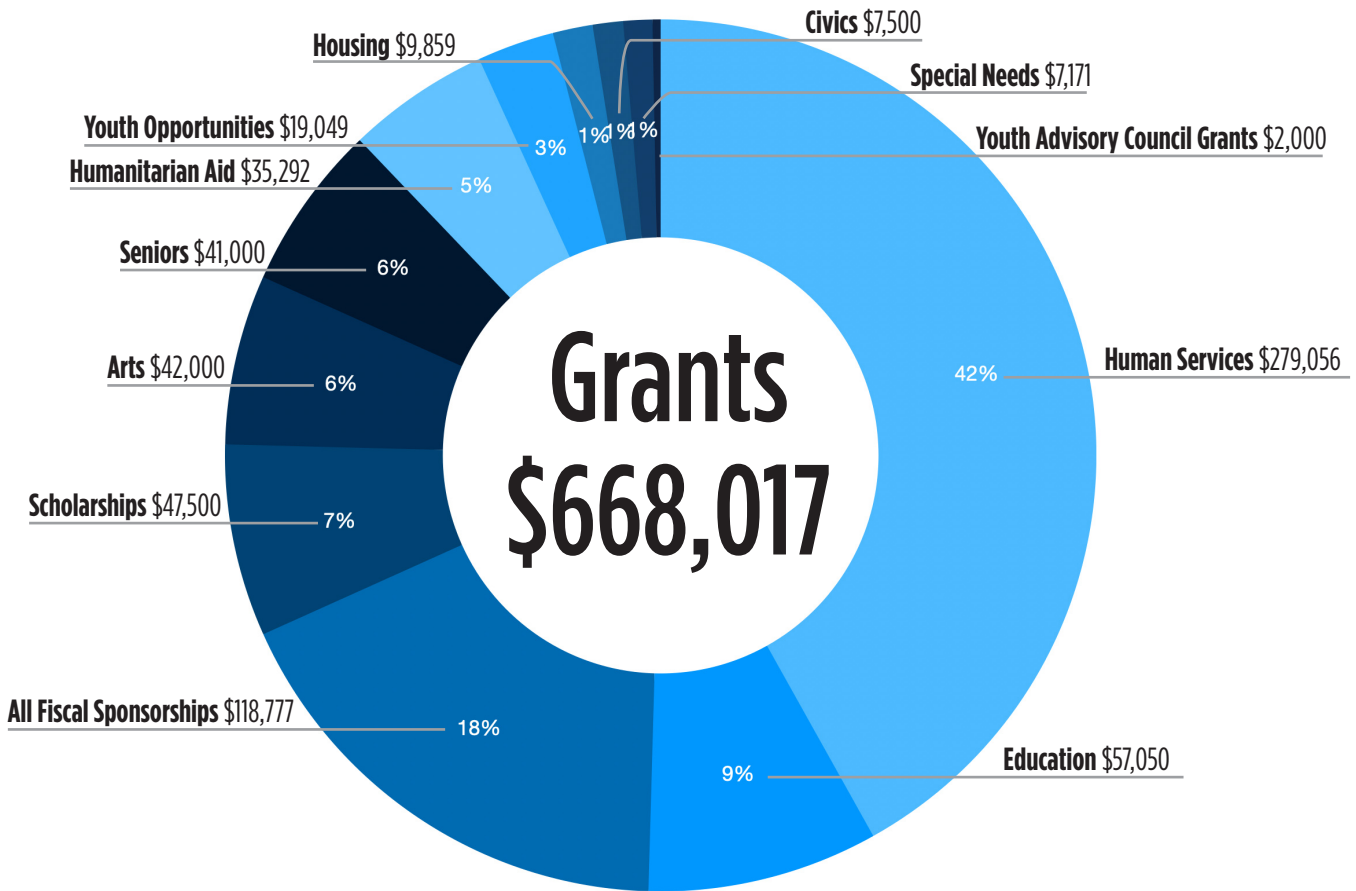
By partnering with the City & County of Broomfield Department of Human Services, and expanding it further in 2024, we've streamlined funding efforts for greater impact.

2024 GRANTS

The purpose of the Broomfield Community Foundation is twofold. First, we aim to grow the Foundation's fiscal resources to support our varied grants programs, directly benefiting Broomfield residents. In 2024, we awarded \$668,017 in scholarships and grants, bringing our total impact to over \$6.5 million with over \$3.4 million of that within the last 5 years.

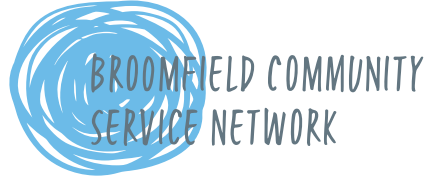


*In 2024, the Paige Foundation disbursed a one-time grant to a CU-Boulder's scholarship program.

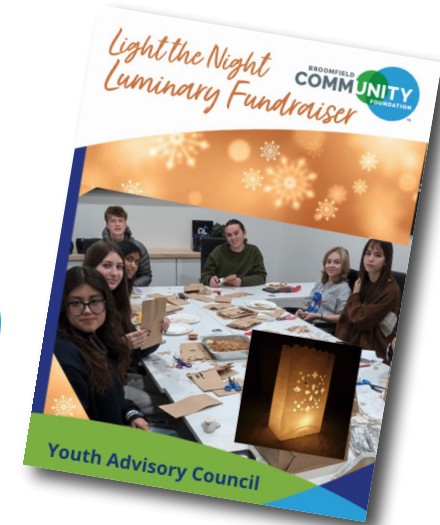

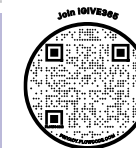
