If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.





Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

BASIC SERVICES OF FUNERAL DIRECTOR, STAFF & OVERHEAD

\$325

This fee is for our basic services and overhead. It will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation). This fee includes communication with our team via phone, text and email; preparation and filing of necessary documents including - California Death Record (death certificate), California disposition permit* and Statement of Death by Funeral Director for Social Security Administration. This charge does not include scheduling, planning or participating in memorial services.

****Note - additional charge applies for refiling a disposition permit after the initial permit has been issued - reasons to refile a permit include change in jurisdiction or change of location within Kern County, dividing cremated remains, or change in type of disposition.***

DIRECT CREMATION RANGE

\$845 - \$895

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are corrugated paper (cardboard).

The purchaser may also provide an alternative container, provided it meets all state and crematory requirements.

DIRECT CREMATION WITH AN ALTERNATIVE CONTAINER

\$895

Our charge for a direct cremation (without ceremony) includes: our basic services of funeral director and staff, transfer of the decedent (within 30-mile radius - this includes Delano, Taft and Arvin), delivery to the crematory, refrigeration for up to 5 business days, an alternative cremation container, crematory fee, and one durable urn.

Our average timeline is 6-8 business days. However, certain circumstances require additional time for filing of required documents. The urn will be available 3 business days after registration of the death record. Registration of the death record requires the timely cooperation of the decedent's physician, medical providers and in some cases, the medical examiner or coroner.
