We comply with the Data Protection Act 2018 and the UK GDPR together with any other relevant data protection and privacy legislation (together "Data Protection Legislation"). We are the data controller of data you pass to us pursuant to this policy.

This Privacy Policy sets out how we collect personal information from you and how the personal information you provide will be processed by us. What Information Does The Bungalow Care Home Hold and How Will We Use It?

Information You Give The Bungalow Care Home

You may give us information about you by completing enquiry forms on the website or by requesting via the website that we send you marketing information. The information you give us may include your name, email address, address/location and phone number.

We will retain this information while we are corresponding with you or providing services to you or to the Service User you represent. We will retain this information for a period of up to 3 years from the date of last contact, or for as long as required by applicable legislation or regulatory guidance, including the Records Management Code of Practice for Health and Social Care.

Information The Bungalow Care Home Collects About You

The Bungalow Care Home may collect the following information from you when you visit the website:

- Technical information, including the Internet protocol (IP) address used to connect your computer to the Internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform; and
- Information about your visit, including the full Uniform Resource Locators (URL), clickstream to, through and from the website (including date and time), products you

viewed or searched for, page response times, website errors, length of visits to certain pages, page interaction information, and methods used to browse away from the page.

We retain this technical and usage data for up to 12 months from the date of collection, in accordance with our data retention schedule.

Information We Receive From Other Sources

This includes information we receive about you when you use other websites operated by us or other services we provide. This information may include your name, email address, postal address and phone number. We will retain this information for up to 3 years from the date of last contact, or as required by applicable legislation.

Cookies

The website uses cookies to distinguish you from other users of the website. For detailed information on the cookies we use and the purposes for which we use them, please see our Cookie Policy available on the Website.

Use Made of the Information

We may use the information we receive and/or collect about you via the website to:

How Safe Is Your Information?
