Rules governing the January 24 & 25, 2026 Otto/MEGA Handicapping Challenge:

- Rule 1. Enter November 26, 2025 – January 24, 2026. Enter at the Fonner Keno service counter. No entries taken **after** January 24, 2026.
- Rule 2. As per IRS regs, an entrant may have to complete a W-2G prior to collecting any winnings that meet W-2G requirements.
- Rule 3. The required beginning account balance is \$200 and no funds may be added to the account other than via winning wagers.
With computerized accounting restrictions, no account funds may be withdrawn until conclusion of the final challenge race on 1.25.26.
- Rule 4. If you wish to withdraw your challenge balance, please do so at the Keno service window where your entry was processed.
- Rule 5. To withdraw your challenge balance, you must surrender your account card and produce positive identification.
- Rule 6. It is not necessary to withdraw your account funds immediately after the final challenge race; you may withdraw at a later date, or we will make other arrangements if necessary (upon surrender of your account card and a copy of positive identification).
- Rule 7. An official contest account card and simulcast program will be distributed to each entrant on January 24 prior to the first challenge race.
The first challenge race will be the first race presented among the racetracks on the Fonner Park daily simulcast schedule of racetracks, on Day 1, January 24, 2026. The contest ends after final designated contest race (TBA before January 24) Day 2, Sunday, January 25, 2026.
- Rule 8. Challenge wagers must be made at designated challenge mutuel windows only located at Fonner Park.
- Rule 9. To be eligible for contest prizes, contestants must wager a minimum of \$200. Contestants may purchase two entries only for this contest.
- Rule 10. If a contest account has no play on Day 1, unused accounts on Day 2 may not be managed by, or allocated to, another contestant, other than the named account entrant at the entry sign-in time/date. ALL CONTEST ACCOUNTS MUST HAVE A NAMED CONTESTANT.
- Rule 11. Win, Place, Show, Exacta, Trifecta, Double, and P3 are permitted. Wager amount(s) are limited to contestant account balance.
- Rule 12. Challenge standings are based on account balances and will be updated and displayed on designated television monitors.
- Rule 13. Prize payouts to the top-eight finishers will be distributed upon conclusion of the challenge. This distribution will be made at the same Keno service window that processed your entry. Your account card and positive identification will be required. Total entry fees/prize money divided as follows: 1st – 50%, 2nd – 25%, 3rd – 10%, 4th- 5%, 5th – 4%, 6th 3%, 7th – 2%, 8th – 1%.

Winner receives one overnight stay and dinner at Ruthie’s steakhouse at any Elite Casino Resorts property.
Transportation is not included.
