Weights: Three-Year-Olds, 121 lbs.; Older, 125 lbs. Non-winners of \$9,000 twice in 2025-2026 allowed 3 lbs., Of \$9,000 in 2025-2026, 5 lbs. Maiden, Claiming and Starter races not considered in allowances. High Weights preferred on the scale. Total earnings in 2025-2026 will be used in determining the order of preference of horses assigned equal weights.
