**PUBLIC HEARING: School District's Rating On The State's Financial Accountability Systems - 6:00 pm**

Mr. Hernandez presents to the board, The School FIRST (Financial Integrity Rating System of Texas) ensures that districts are held accountable for strong financial management and effective use of resources to support student instruction. Districts are required to submit an annual financial management report that includes their TEA-issued rating, performance on each indicator, and additional disclosures such as the superintendent's contract, reimbursements, consulting fees, gifts, and business transactions. The FIRST system includes 21 indicators, with four critical indicators that automatically result in a failing rating if not met, and several ceiling indicators that limit the maximum possible score. Ratings range from A (Superior) to F (Substandard). For the 2024–2025 rating (based on 2023–2024 data), Progreso ISD scored 96 out of 100, earning a rating of A – Superior Achievement. The district met all critical indicators, complied with financial reporting timelines, maintained strong fund balance, demonstrated responsible spending, met transparency requirements, and showed no material weaknesses or compliance issues in its audit. Required public disclosures for the School FIRST hearing include the superintendent's employment contract, which is posted on the district website.

He also announced that the Christmas Parade will take place on December 17 and informed the Board that National Bus visited the district to showcase the Chatter Bus, which could serve as a strong investment opportunity. #### **C1 LASO 4: Leadership & Instructional Foundation for Texas**

*Mrs. Garcia presents to the board, The LIFT Grant is a three-year TEA initiative aimed at strengthening instructional leadership and improving the use of high-quality, grade-level instructional materials. It provides support through coaching, technical assistance, and leadership development. Board approval is required to adopt the selected materials, and teacher support must be documented. Up to 30% of grant funds may be used for discretionary instructional items, while at least 70% must be directed to an approved provider. The administration recommends approving Bluebonnet Learning Mathematics for Grades K–8 and Algebra I, contingent upon receiving the LASO 4 award.*

*Mr. Juan Hernandez informs board of trustees of the total revenue 20.4 million total expenditures 20.7 million. Fund balance deficit of \$231,000*

**G-      Governance:**

**G1 policy Update 126**

*Mr. Coronado and Eden Ramirez present to the board, TASB Update 126 reflects changes primarily from the 89th Legislative Session and updates multiple legal and local policies across governance, accountability, board operations, and district designations. Key revisions include updated educational goals, changes to District of Innovation and Home-Rule district requirements, new accountability rules, and adjustments related to investigations and intervention programs. Several governance policies were revised, including new restrictions on trustee eligibility (such as disqualification for registered sex offenders), the option to change trustee term lengths and election dates, and new rules for conducting elections. Board meeting requirements were significantly updated, including mandatory recording of all meetings, posting agendas for three business days instead of 72 hours, roll-call voting, and updated guidelines for agenda submission. Additional policies address access to information, cybersecurity topics in closed session, and training updates for board members. Overall, Update 126 ensures district policies align with new state laws and administrative rules. Update 126 includes extensive changes across tax, purchasing, safety, contracted services, and facilities policies to align with new state legislation.*

**Tax & Budget Policies:**

*Updates reflect new homestead and elderly/disabled exemptions (pending constitutional amendments), changes to split-payment rules, revised economic development statutes, and updated requirements for tax rate propositions, including mandatory "THIS IS A TAX INCREASE" language. Procurement thresholds increase to \$100,000, and new limitations are placed on disaster pennies.*

**Purchasing & Vendor Requirements:**

*New laws establish criminal penalties for vendors with close ties to trustees, restrict vendor involvement in prohibited instructional or DEI activities, and clarify prompt-payment exceptions for construction disputes.*

**Contracted Services & Background Checks:**

*Significant updates require stricter reporting of contractor misconduct, expanded background check requirements, restrictions on severance agreements, and updated provisions for disqualifying convictions.*

**Safety & Security:**

*Major revisions reflect new mandates across emergency planning, cybersecurity, school safety meetings, AED inspections, emergency maps, firearm storage notifications, and disability accommodations during emergency planning. Laws expand requirements for armed security personnel, school marshals, police department communication officers, and access to specialized safety equipment.*

**Facilities & Operations:**

*Districts must now report facility usage to TEA. Fire safety inspections must include AEDs, and displays such as the Ten Commandments must be posted per new legislation. Additional clarifications are included regarding required displays, equipment management, and instructional materials.*

*Overall, these revisions update district policies to comply with recent legislative changes, increase safety and oversight requirements, strengthen procurement regulations, and ensure transparency across financial and operational practices.*

*The purpose of this memorandum is to provide an overview of the two transition models the District may adopt to move from its current annual election structure into a four-year trustee term framework with biennial elections. These options were developed after consultation with the Texas Legislative Council, a process coordinated for the District through Representative Armando "Mando" Martinez. Their guidance has been instrumental in ensuring the District's transition reflects legislative intent and complies with the statutory framework governing school district elections. Both options presented Option 1 (May Elections) and Option 2 (November Elections) accomplish the same objectives. Each option transitions Progreso ISD to four-year trustee terms, restores a true biennial election cycle, and maintains the required staggering of trustee positions. The difference between the two is solely the choice of uniform election date. Option 1 aligns the District with the May election date commonly used by the local public junior college district. Option 2 aligns the District with the November uniform election date used for state and county general elections. Under either path, the District will be participating in joint elections with another governmental entity, a structure that the Legislative Council interprets as central to how Texas Education Code § 11.0581 is intended to operate. The Legislative Council indicated that, when reading § 11.0581 together with § 11.059 and the amended provisions adopted by the Legislature, school districts are expected to conduct their elections on a uniform election date shared with at least one of the entities listed in §11.0581.*  
*Moving to four-year terms and biennial elections is consistent with this interpretation and provides long-term calendar stability. Both transition models have been designed to ensure that no trustee's current elected term is shortened. Where necessary, trustees may continue serving under the constitutional holdover provision in Article XVI, Section 17 until their successors are elected and qualified. This ensures a smooth and orderly transition without disruption to governance or voter expectations. In addition, by eliminating annual elections and consolidating into a true biennial cycle, the District is projected to save approximately \$200,000 over the next twelve years, based on historical election expenditures. The two attached options provide the Board with a clear, legally supported path forward. Either option brings Progreso ISD into alignment with the current statutory landscape, reflects the Legislative Council's interpretation of legislative intent, and enhances fiscal efficiency and long-term planning.*




