## **OPEN CLASS GENERAL RULES FOR VEGETABLE AND FLOWER SHOW**

1. Open Class is for Indiana amateur growers over age 18 not participating in 4-H. An amateur is a person who earns less than \$1000 annually in a horticulture-related industry.
2. A Department Superintendent is appointed to supervise each individual show – Vegetable Department and Flower Department.
3. Superintendents shall, when called upon by the judge or an exhibitor give an explanation of the rules governing an exhibit, and shall also decide all questions and disputes.
4. Superintendents shall prevent anyone from interfering with the judges while judging an exhibit; they are empowered to enforce rules governing the exhibits.
5. Superintendents shall refrain from expressing an opinion as to the merit or demerit of any exhibit when talking in the presence of a judge.
6. All exhibits must remain in place throughout the fair or as released by the superintendent.
7. A faithful observance of all rules governing the exhibits will be required and when in doubt as to the application or intent of a rule, the superintendent shall clarify the rule.
8. No distribution or posting of advertising shall be allowed.
9. The Porter County Fair will not act as a selling agent and no article can be shown with a “For Sale” sign in view.
10. The Fair Board is not responsible for loss or damage to any exhibit.
11. In the event of conflict between general and department rules, the latter shall govern.
12. There is to be no entry fee assessed in any department. Ribbons and premiums will be awarded for the first three placings and honorable mention for exhibits deemed worthy by the judges. Judges shall not award prizes to unworthy exhibits.

## VEGETABLE SHOW DEPARTMENT RULES

1. **See General Rules on page 1.**
2. **Location** – The Vegetable Show area is located in the Expo East building of Porter County Fairgrounds. Use the east door to enter your exhibits.
3. **Timing** – Exhibits are due Thursday, July 23 from 8am to 10am. To accommodate working gardeners, exhibits will be accepted Wednesday July 22 from 5pm to 7pm.  
Judging is Thursday, July 23 at 11am.  
Exhibits are released Saturday, August 1 between 8p and 9p. The Superintendent shall discard any exhibits not picked up by 9pm.
4. **Limit** – Exhibitors cannot enter more than one item per section. All exhibits must be grown by the exhibitor or his/her family.
5. **Plants** – Some vegetables will not keep in good condition during the entire fair. The Superintendent reserves the right to discard any exhibits whenever they do not make a good appearance.
6. **Tools** – The Fair Board will furnish trays for vegetable exhibits.

## TALLEST CORN CONTEST

Enter one stalk of corn grown from a recognized seed variety for grain purposes. Stalk should be entered with root system intact, in a 5-gallon bucket.

## FLOWER SHOW DEPARTMENT RULES

1. **See General Rules on page 1.**
2. **Location** – The Flower Show area is located in the Expo East building of the Porter County Fairgrounds. Use the south door to enter your exhibits in the Flower Show and have them placed.
3. **Timing** – Not all exhibits are brought in on the same day. Consult the Handbook for the three days during the fair when new exhibits are submitted and placed. (Placement Day) This keeps the Flower Show exhibits fresh and provides room for many Classes.
4. **Limit** – One exhibit is allowed by an exhibitor for each Class/Subclass. Exhibitors may enter as many Classes as desired. Exhibitors from the same family or exhibitors using the same garden may participate in the same Class, but cannot submit exhibits from the same bush/tree/cultivar.
5. **Plants** – Exhibits from trees, shrubs and perennials must be grown by the exhibitor in your garden for at least one year and annuals for at least 6 weeks. Exhibits need not be grown from seed by the exhibitor.
6. **Tools** – Prior to the fair, a hard copy of the Handbook and Identification Tags (ID Tags) for exhibits may be picked up at the Fair Office 219.462.0321 or contact the Flower Show Superintendent. Knowing the rules in the Handbook and completing ID tags ahead of time is highly recommended. These tools will also be available on Placement Day and during the fair.
7. **ID Tags** – Each exhibit in the Flower Show must have an ID Tag attached which is the responsibility of the exhibitor to complete. The exhibitors full name is required, an address is not, however address labels may be used. The Section and Class are required. The botanic name (Genus/species) is recommended for each exhibit. ID Tags with complete botanical names will be given more points. Neither the Flower Show Superintendent nor staff will help complete your ID Tag. Use the attached strings to tie the ID Tag to the vase.
8. The staff will place the exhibit on a shelf in the Flower Show area according to the Section and Class on the ID Tag with the Tag facing out and the name hidden. Exhibitors are not allowed in the Flower Show area at this time.
9. Exhibits must be placed in a clear glass vase of water, not soil. Vases and

water are available on Placement Days at tables outside the south doors for your convenience. Exhibitors may use their own clear glass vase, but the Porter County Fair is not responsible for it. Exhibitors must have name and address on the bottom. If not, they will become the property of the Porter County Fair.

10. No foliage should be below the water line.
11. Clear plastic wrap may be used in the vase neck to secure the flower stem for posing, but it must not appear above the top of the vase.
12. Exhibits may not be treated in any manner with sprays on leaves other than water. Exhibits can be clipped and groomed.
13. No ribbons will be awarded unless the exhibit is worthy, even if it is the only exhibit in the class.
14. Trained judges view all the exhibits that day and award stickers are placed on the ID tags. Exhibits are displayed for 3-4 days at the fair.
15. Judges may not enter exhibits on days when they judge.
16. Judges' decisions are final. Direct questions to the Superintendent.

### **SPECIAL RULES FOR DESIGN EXHIBITS (SECTIONS A AND B)**

1. Design must be created by the exhibitor.
2. Floral designs may be arranged in containers that are not clear glass and are provided by the exhibitor, as well as under cloths and any desired accessories, including wet floral foam. Name and address on the bottom of the container is required. Porter County Fair is not responsible for your items. See pick-up info in Handbook for each Placement Day.
3. Designs are permitted to include purchased fresh plant material.
4. Plant material may not be dyed or otherwise treated by application of any substance. It may be clipped, stripped, bent or otherwise manipulated. No artificial plant material is permitted.
5. Accessories are permitted. Religious symbols used must be displayed in a respectful manner and in accordance with local church policy. All national flags must be displayed according to proper flag etiquette.
6. Designs are displayed on white shelves, and an under cloth is required. Maximum size listed includes the under cloth.
7. Exhibitor must complete their ID tag. Botanic names are optional.
8. Exhibitors place their design with ID tag alongside in the location designated by the Superintendent.
9. Designs will be viewed by the judges from the front only.
10. Best of Section and Best of Show may or may not be awarded.

Exhibits are submitted between 7am and 9am, closing at 9am. Please allow enough time to complete your ID Tag for each exhibit. Pick up any personal items on Sunday 6pm-7pm or Monday 7-9am. Thereafter, items become property of Porter County Fair. Contact Superintendent, if needed.

**SECTION A – MINIATURE DESIGN**

Class 1 Creative design

Must be sized 8”L x 8”W x 8”H or less.

Class 2 Creative design using herbs only.

Must be sized 8”L x 8”W x 8”H or less.

Class 3 Creative design using one Genus of flower.

Must be sized 8”L x 8”W x 8”H or less.

Class 4 Creative design in a mug.

Must be sized 8”L x 8”W x 8”H or less.

**SECTION B – STANDARD DESIGN**

Class 5 Creative design in a can. Leave the label on the can.

Must be sized 14”L x 14”W x 14”H or less.

Class 6 Creative design using flowers of one color.

Must be sized 14”L x 14”W x 14”H or less.

Class 7 Creative design using only foliage of different shades and textures.

Must be sized 14”L x 14”W x 14”H or less.

Class 8 Creative design using uncultivated plants.

Must be sized 14”L x 14”W x 14”H or less.

Class 9 Creative design with a fair theme.

Must be sized 14”L x 14”W x 14”H or less.

Class 10 Creative design using only hydrangeas and fresh plant material.

Must be sized 18”L x 18”W x 18”H or less.

**SECTION C – RHIZOMES**

Only one leaf is exhibited.

Class 11 Hosta (Plantain Lily).

A. Green, all shades, solid color.

B. Blue, all shades, solid color.

- C. Yellow, all shades, solid color.
- D. White margin, center green to blue color which is distinct from white.
- E. Yellow margin, center green to blue color which is distinct from yellow.
- F. Green or blue margin, Center color yellow, white, or chartreuse which is distinct from the margin color.
- G. Green or blue margin, Center color green or blue which is distinct from the margin color.
- H. Streaked or mottled.
- I. Bloom only, one stem.
- J. Mini Collection – Five different leaves less than 5” each in its own vase, each having its own ID tag with botanic names.
- K. Large Collection – Five different leaves more than 5” each in its own vase, each having its own ID tag with botanic names.

One stem with bloom(s) unless otherwise stated.
