

Official Rules

Family Heating, Cooling & Electrical -Install to Win Sweepstakes", 2025

1. **Eligibility: Family Heating – RED WINGS “Install to Win”** (the “Sweepstakes”) is open only to legal residents of Michigan who are at least eighteen (18) years old at the time of entry. Employees of Olympia Entertainment, Inc., Olympia Entertainment Events Center, LLC, Detroit Red Wings, Inc., the NHL and Family Heating, Cooling & Electrical and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such entity are not eligible. Subject to all applicable federal, state and local laws and regulations. Void where prohibited. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. 4. **How to Enter:** Purchase and install a new furnace, air conditioner or standby generator through Family Heating, Cooling & Electrical within one of the eligibility date ranges, to be entered to win a **FAMILY-to-FAMILY package of 4 tickets to the Detroit Red Wings game. INCLUDES:** Tickets with food and beverages in a Private Club at Little Cessars Arena. *(approximate retail value \$1500 per prize package)*

Limit one (1) entry per person. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different, identities, registrations or any other methods will void that entrant's entries and that entrant will be disqualified.

Mail-in entries must be received by the drawing date of each drawing date specified. The drawings will take place on the dates written in #3/timing above. 4 **Release:** By accepting any prize, each winner agrees to release and hold harmless Sponsor, Olympia Entertainment, Inc., Olympia Entertainment Events Center, LLC, Detroit Red Wings Inc., the National Hockey League and its Member Clubs, Family Heating, Colling & Electrical, and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and prize suppliers, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Sweepstakes or receipt or use or misuse of any prize.
