**Orders Sons and Daughter of Italy New Jersey Grand Lodge  
Mother's Day Craft Fair Requirements**

**Location:** Sons and Daughters of Italy Grand Lodge  
**Address:** 510 Marlboro Avenue, Cherry Hill, NJ 08002

**Size:** Spaces are 10' wide x 10' deep. All merchandise, displays and vendors must fit within the framework of this space with approximately 1-18 inches between spaces. You must provide your own table/tent/tent weights. **All Tents must have 20-pound tent weights on each leg of tent. Vendors who are not properly set up may be asked to refrain from participating. Electricity is NOT available.**

**Food Vendors**

All vendors selling food will be required to get approval and licensing from the Camden County Health Department.

**Space Assignments:** The OSDIA Craft Show Committee will assign vendor spaces. You will be given your location upon arrival to the event for set-up.

**Parking:** Street parking for vendors is available along Marlboro Avenue outside of the designated Vendor spots.

**Set Up:**

Begins at 8:00AM. Vendors must be set up by 9:30AM. Vehicles WILL NOT be permitted to enter the designated area after 9:30AM and must be out of the Market area no later than 9:30AM

**Break Down**

May not begin before 4:00 PM. Cars will not be permitted in the area until 4:00PM.

**\*\*\* You must be completely broken down BEFORE you bring your car into the area.**

**Clean-up:**

Vendors MUST remove all trash from their space. DO NOT leave cardboard boxes, bags, etc. All spaces must be clean and free of debris & garbage at the end of the market, or the vendor will not be invited back to future events.
