## 2024 Preschool Camp Tuition Agreement

- This agreement applies to New Morning preschool camp programs located at 23 Back River Rd.
- Preschool and kindergarten age children may be enrolled in Preschool Camp during February Vacation, April Vacation, or during the 10 Summer Camp weeks. The regular camp day is from 9 AM - 2 PM for preschool students. Please note that these hours differ from our IMAGINE camp for school age children. We only offer weekly rates for preschool campers. Please see attached for camp pricing.
- Before and after camp care is available with no prior notice. Before camp hours begin at 7:30 AM. After camp care continues until 5:30 PM.
- Camp tuition is due upon registration and is non-refundable.
- Tuition Express is required for all camp programs.
- Extended care charges will be added to your ledger by the Monday following camp attendance. Weekly auto-payments are processed each Tuesday.
- Statements are emailed each Monday afternoon. Statements may be sent to up to two email addresses. Please ensure that we have a working email address.
- If auto-payment charges are declined, you will be charged a \$25 decline fee. There is a \$30 fee for returned checks. Please call with alternate payment arrangements if you anticipate an issue.
- If you are eligible for state assistance, you must arrange for your child to be linked to New Morning. We do not submit paperwork on your behalf. Full weekly payment is due before the child's first day of attendance. You must sign weekly alternate billing paperwork each day your child attends. State scholarship payments will appear as a credit on your account after funds are received. We are not allowed, per scholarship rules, to bill the state until after the child has attended the program.
- Please pick up your child on time. A \$1.00 per minute late fee will be added after the program close time.
- We reserve the right to prohibit your child from our program for non-payment of fees, repeated late pickups, or child or parent behavior that causes a safety concern or disruption of the program.
