2026 IMAGINE Camp Tuition Agreement

- This agreement applies to New Morning school age camp programs located at 23 Back River Rd.
- Children may be enrolled in IMAGINE Camp during February Vacation, April Vacation, or during the 10 Summer Camp weeks. Additional camp days are offered to school age students throughout the school year. Please see our website for updates on day camp sessions offered.
- The regular camp day is from 7 AM - 6 PM for school age students. See below for camp pricing. We offer both daily and weekly rates for school-age campers.
- Tuition Express is required for all camp programs.
- Upon registration, a \$50 non-refundable camp tuition payment is due per session. The remaining camp tuition will be charged two weeks prior to scheduled attendance.
- Students need to be enrolled a minimum of 2 weeks before their scheduled camp week. Late camp sign-ups will be charged an additional \$25 fee for the camp week.
- Summer enrichment fees will be added to your ledger upon registration. Enrichment fees are non-refundable.
- Weekly auto-payments are processed each Tuesday.
- Statements are emailed each Monday afternoon. Statements may be sent to up to two email addresses. Please ensure that we have a working email address.
- If auto-payment charges are declined a \$25 decline fee will be charged. There is a \$30 fee for returned checks. Please call with alternate payment arrangements if you anticipate an issue with payment.
- If you are eligible for state assistance, you must arrange for your child to be linked to New Morning. We do not submit paperwork on your behalf. Full weekly payment is due before the child's first day of attendance. You must sign weekly alternate billing paperwork each day your child attends. State scholarship payments will appear as a credit on your account after funds are received. We are not allowed, per scholarship rules, to bill the state until after the child has attended the program.
- Please pick up your child on time. A \$2.00 per minute late fee will be added after the program close time.
- We reserve the right to prohibit your child from our program for non-payment of fees, repeated late pickups, or child or parent behavior that causes a safety concern or disruption of the program.
