These prices are effective as of the date shown above and are subject to change without prior notice.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Direct cremation is a disposition of human remains by cremation, without formal viewing, visitation, or ceremony with the body present.

STANDARD CHARGES

Basic Services of Funeral Director and Staff	\$300.00
• 24-hour availability to respond to your request for services • Conference with the family • Preparation and delivery of the original death certificate to the certifying physician • Obtaining cremation approval from the county medical examiner • Filing of the original death certificate with the Office of Vital Statistics • Notification of death to the Social Security Administration	

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charge for a direct cremation.)

Transfer of Remains to the Crematory	\$300.00
---	-----------------

Includes removal of the deceased from the place of death and transport to the crematory within our 25-mile service area.
Transportation beyond 25 miles is charged at \$4.00 per loaded mile (see Additional Services below).

Alternative Cremation Container	\$20.00
--	----------------

A casket is not required for direct cremation, but a container to encase the body is required by law. You may use an alternative container for direct cremation. Alternative containers encase the body and can be made of materials such as fiberboard or composition materials, with or without an outside covering. The containers we provide are fiberboard. You, the purchaser, have the option of providing your own cremation container and deleting this charge from our fees.

Refrigeration (Alternative to Embalming)	\$125.00

As a direct disposal establishment, we do not perform embalming. Refrigeration is used to hold the deceased pending cremation.

Cremation Process (Crematory Fee)	\$250.00

Decedents exceeding 250 pounds require additional handling and a reinforced cremation tray, and additional charges apply based on weight (see Additional Services below). Our maximum weight is 600 pounds.

DIRECT CREMATION

Our charge for a direct cremation includes: the basic services of the funeral director and staff and our overhead; transfer of the remains to the crematory within our 25-mile service area; refrigeration; an alternative cremation container; a temporary container for the cremated remains; and the cremation process itself.

Direct cremation with an alternative container provided by us (fiberboard) \$995.00

Direct cremation with a cremation container provided by the purchaser \$975.00

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard.

Under FTC regulations, those who offer direct cremations are required to tell you that Florida state law does not require embalming or the use of a casket for direct cremation.

ADDITIONAL SERVICES & MERCHANDISE

Priority Service (Cremation Completed Within 48 Hours of All Approvals and Paperwork) \$495.00

Additional Transportation Beyond 25-Mile Service Area (Per Loaded Mile) \$4.00

Travel Protection (One-Time Purchase) \$500.00

A one-time purchase, made in advance, that covers transfer of the deceased into our care when death occurs more than 75 miles from the decedent's place of residence. Where this coverage applies, no per-loaded-mile transportation charge, forwarding charge, or receiving charge is billed to the family. It does not cover the direct cremation itself or any other item on this price list, and it does not cover cemetery or other third-party charges. This purchase does not expire and is not subject to renewal or increase. Full terms are provided in writing before purchase.

Special Handling — Decedents Over 250 Pounds see below

251–350 lbs **\$95.00** • 351–450 lbs **\$190.00** • 451–550 lbs **\$285.00** • 551–600 lbs **\$380.00**

Cremation of a decedent over 250 pounds requires additional handling, equipment, and cremation time. \$95.00 applies for the first 100 pounds over 250, and an additional \$95.00 for each 100 pounds thereafter. Maximum weight is 600 pounds. A reinforced cremation tray is also required and is charged separately.

Reinforced Cremation Tray (Required for Decedents Over 250 Pounds) \$150.00

Extended Refrigeration (Per Day) \$200.00

Applies automatically for each day beyond 48 hours that any required document has not been returned to us and the deceased must remain in our care.

Mailing of Cremated Remains \$195.00

Hand Delivery of Cremated Remains \$195.00

Placing Cremated Remains in an Urn Not Purchased From Us \$50.00

Urns (Starting At) \$65.00
