We will not conduct visitations or funeral/memorial services on the following holidays to allow our employees time with their families: New Year's Eve, New Year's Day, Easter, Memorial Day, Fourth of July, Labor Day, Thanksgiving, Christmas Eve, and Christmas Day.

ITEMIZED PRICE LIST

The goods and services shown on the following pages are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

PROFESSIONAL SERVICES AND OVERHEAD

Basic Services of Funeral Director and Staff \$2,700

Our basic services fee includes, but is not limited to: The services of our funeral directors and staff to respond to initial request for service; arrangement conference with family or responsible party for recording of vital statistics and preparation of necessary authorizations and permits, and preparation and publication of obituary notices; staff assistance prior to and following the services; and assistance with planning the services and coordination of service plans with other third parties as needed.

Also included in this fee is a proportionate share of our fixed operating expenses relative to our facilities, professional licensing, legal and accounting, insurance, utilities, maintenance, taxes, furnishings and inventory costs, and administrative costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremation, immediate burial, and receiving or forwarding of remains.

PREPARATION AND CARE OF THE DECEASED

Embalming \$750

Except in certain special cases, embalming is not required by law. Embalming may be necessary if you select certain funeral arrangements such as a funeral with a viewing. If you do not want embalming, you have the right to choose an arrangement that doesn't require you to pay for it, such as direct cremation or immediate burial, or when refrigeration or dry ice is available.

Other Preparation of the Deceased \$350

Cosmetology, dressing and placement in casket, and other preparation if required.

Alternative Sanitary Care of Deceased \$150

Disinfection of the body, if no embalming, as required by Wisconsin statute DHS 136.04.

Restoration of Unembalmed Remains following Autopsy (For private viewing) \$395

Includes sanitary care of the deceased.

Cremation Fee \$225

Provided by Schumacher-Kish Funeral and Cremation Services, Inc. License No. 105-98

FACILITIES/EQUIPMENT/ADDITIONAL STAFF SERVICES

For Visitation or Memorial Gathering \$400

For visitation or gathering of up to three hours in the evening before funeral or memorial service within our facilities or another location.

For Funeral or Memorial Service \$750

For funeral or memorial service within our facilities or at another location. Includes one hour of visitation or gathering.

Add \$150 for each additional hour of visitation or gathering, or portion thereof.

For Graveside Service and Committal Oversight \$150

For procession to cemetery and/or committal rites and oversight.

For Private Family Viewing \$250

For one hour of private family viewing between the hours of 9:00 a.m. and 3:00 p.m. on regular weekdays.

For facilities, equipment, and staff for luncheon within our facility for 2 hours.....\$200

Lunchroom Hours: Monday thru Friday 10:00 AM – 7:00 PM Saturday/Sunday 10:00 AM – 3:00 PM

Add \$150 for each additional hour or portion thereof.

ITEMIZED PRICE LIST - continued

TRANSPORTATION AND AUTOMOTIVE EQUIPMENT

Transfer of the Deceased to our Funeral Home \$550

Staff and equipment for initial transfer of the deceased to our funeral home within 25 miles. Additional mileage charged at \$3.00/mile, one way, for destinations beyond 25 miles.

Funeral Coach (Hearse) - Provided by La Crosse Coach Service \$475

La Crosse Coach Service will determine any additional charges for additional mileage.

Utility/Lead Vehicle \$125

Used as lead vehicle for procession as well as for service errands and transporting equipment.

Additional mileage charges of \$3.00/mile, one way, for destinations beyond 25 miles

DIRECT CREMATION

Wisconsin and Minnesota law does not require you to purchase a casket for cremation. If you wish to arrange for direct cremation, you may use a cremation container. A cremation container is a combustible, closed container that encases the body and can be made of materials like fiberboard or corrugated cardboard which a dead human body is placed prior to insertion into a cremation chamber for cremation. The containers we provide are made of corrugated cardboard and fiberboard.

FTC Funeral Rule does not require you to purchase a casket for cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are made of corrugated cardboard and composite wood.

Direct Cremation..... \$3,475 to \$6,570

Our fee for direct cremation includes the basic services of funeral director and staff and our overhead, initial transfer of the deceased to our funeral home, alternative sanitary care of the deceased, use of utility/lead vehicle, corrugated cardboard cremation container, and basic plastic urn.

Crematory Fee.....\$225

With container provided by family or third party.....\$3,380

With basic cremation Alternative container provided by funeral home..... \$3,475

With Hadley alternative container.....\$4,675

With casket purchased from funeral home..... \$3,380

(Does not include the cost of a casket)

OTHER SERVICES

Immediate Burial (no services) \$3,350 to \$8350

Our fee for immediate burial, without services, includes the basic services of the funeral director and staff and our overhead, initial transfer of the deceased to our funeral home, alternative sanitary care of the body, use of facilities for private family viewing if desired, and use of utility/lead car for local transportation to the cemetery. The casket or alternative container and outer burial container (if required), additional transportation charges, or any cash advances are not included in this fee. This package does not include procession to cemetery and/or committal rites and oversight.

Immediate Burial with container provided by family or third party \$3,350

Immediate Burial with minimum casket from funeral home \$4,645

Add \$150 for procession to cemetery and/or committal rites and oversight.

Add \$450 for use of Funeral Coach (Hearse) for transfer to cemetery.

Receiving of Remains from Another Funeral Home (casketed) \$1,725

Our fee includes a proportionate share of the basic services of funeral director and staff and our overhead. All other fees for services and use of facilities and equipment will be made from our itemized price list. This fee does not include an outer burial container (if required), additional transportation charges, or any cash advancements.

Forwarding of Remains to Another Funeral Home \$2,895

Our fee includes a proportionate share of the basic services of funeral director and staff and our overhead, initial transfer of the deceased to our funeral home, and embalming. This fee does not include facilities, equipment, or any additional staff services to arrange for and direct any visitation or funeral service, automotive equipment related to a service, additional transportation charges, the casket or any container required for shipping, and any cash advancements.

MISCELLANEOUS SERVICE/FACILITY/TRANSPORTATION FEES

Chapel Usage Fee (Cremation arranged elsewhere)\$1,395

Our fee includes a proportionate share of basic services of funeral director and staff and our overhead. All other fees for services and use of facilities and equipment will be made from our itemized price list.

Medical School Donation (no services) \$1,430

Generally, there is no charge from a medical school for a body donation. However, a donation usually requires the services of a funeral home. Our fee includes a proportionate share of basic services of funeral director and staff and our overhead for the sole purpose of recording vital statistics and gathering signatures for the preparation of permits and authorizations, as well as initial transfer of the deceased to our funeral home. It does not include fees for additional transportation.

Disinterment\$1,295

Our fee includes a proportionate share of basic services of funeral director and staff and our overhead for acquiring permits for disinterment/reinterment and supervision and attendance at disinterment/reinterment. It does not include additional services for visitation, funeral or graveside ceremony, any transportation or merchandise, or any fees of third parties involved.

Transportation Charges \$3.00/mile one way

Our fee includes staff and vehicle to transport deceased to/from a destination other than a cemetery or place of death.

\$4.00/mile one way on weekends and holidays.

MISC. SERVICE/FACILITY/TRANSPORTATION FEES - continued

Weekday evening Funeral or Memorial Service after 4:00 PM.....\$200

Saturday service before 2:00 PM \$300

Saturday after 2:00 PM or Sunday Service.....\$600

Fee added to total funeral home service charges when any service, visitation or graveside committal is held on either weekday evening, Saturday or Sunday.

Refrigeration (per day) \$50

Refrigeration of unembalmed remains is required by the funeral home and at no charge for the first seven days prior to disposition. If final disposition or embalming cannot be performed due to a delay on behalf of the family or authorized agent, the additional fee will be implemented.

MERCHANDISE AND SERVICE-RELATED ITEMS

Caskets \$1,295 to \$5,450

A complete price list will be provided by the funeral home.

Cremation Caskets \$1,295 to \$3,095

A complete price list will be provided by the funeral home.

Alternative Containers \$95 to \$1,295

A complete price list will be provided by the funeral home.

Outer Burial Containers \$1,580 to \$4,175

A complete price list will be provided by the funeral home. Overtime and weekend fees may be added.

Urns, Keepsakes and Cremation Jewelry..... \$25 to \$2,495

Available from inventory or ordered from catalog.

Cremation Outer Burial Containers \$175 to \$695

A complete price list will be provided by the funeral home.

PAYMENT POLICY

Due to the increasing cost of items that are cash advanced for each service, we request that the total of all cash advance items, both actual and estimated, and 25% of the services and merchandise selected, be paid at the time of arrangements unless there is a fully funded pre-arrangement in place. The balance of the funeral account is due within 30 days of the arrangement conference. Any unpaid balance will be subject to a charge of the applicable statutory interest rate until the balance is paid in full.

We offer a variety of payment options which include:

- Payment by a pre-paid funeral contract with our funeral home or transferred from another funeral home.
- Payment in cash, personal check or MasterCard, Visa, American Express, Discover.
- An assignment from the proceeds of a valid life insurance policy.
- In situations where funds are not immediately available, we suggest that you contact your financial institution or other financial services which may be able to assist you.
