These prices are effective as of January 1, 2026

The goods and services shown on this price list are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Funeral Home Professional Services

Basic Services of

Funeral Director and Staff..... \$ 2,675

This fee for the services of funeral director and staff includes, but is not limited to: staff to respond to initial request for service; arrangement conference with family or responsible party; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notices; staff assistance prior to, during and following the funeral; including coordination with those providing other portions of the funeral, e.g. cemetery, crematory and others. Also included in these charges are overhead expenses, secretarial and administrative costs, equipment and inventory costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremation, immediate burials and forwarding or receiving remains.

Embalming..... \$ 1145

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Other Preparation of the Remains.. \$ 375

Includes, but not limited to; cosmetology, hairdressing, barbering, dressing and casketing.

Use of Facilities and Staff for Viewing (per 4 hours) \$ 700

This service includes set-up of visitation area, placement of casketed remains, display of floral arrangements, supervision of and attendance during the visitation (charge per half hour thereafter \$ 75)

Use of Facilities and Staff for Funeral Ceremony..... \$ 795

This service includes coordinating the funeral arrangements, supervision of funeral and staff at funeral ceremony. Price includes admittance one hour prior to service and funeral setup fee.

Use of Equipment and Staff Off-Premise Service..... \$ 500

This service includes coordinating the funeral arrangements, supervision of funeral and staff to attend funeral ceremony.

Use of Facilities and Staff for Memorial Service..... \$ 795

This service includes coordinating the memorial service arrangements, supervision of the memorial service and staff to attend the service. Price includes admittance one hour prior to service and funeral setup fee.

Use of Equipment and Staff for Graveside.....\$ 500

This service includes accompaniment of remains to cemetery, supervision of graveside service (if any) and staff to attend to the interment.

TRANSPORTATION

Unless otherwise noted, all transportation charges contained in this General Price List apply to local area only (within 20 mile radius of funeral home).

Another Funeral Home \$ 4,265

This charge includes removal of remains, necessary services of funeral director and staff, embalming, necessary authorizations, and local transportation to airport.

Receiving Remains from

Another Funeral Home..... \$ 2,875

This charge includes temporary shelter of remains, transportation of remains to cemetery and necessary services of funeral director and staff.

Immediate Burials..... \$ 3,315 to \$ 3,540

This charge for an immediate burial, without any attendant rites or ceremonies, includes local removal and shelter of remains, local transportation to the cemetery, necessary service of funeral director and staff and authorizations.

Direct Cremation \$ 2,450

This charge for a direct cremation without any attendant rites or ceremonies includes removal of remains to crematory, necessary services of funeral director and staff and authorizations. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are: Composition Board Cremation Trays, Minimum Cloth- Covered Caskets and Corrugated Cardboard.
