Harris County Pollution Control Services Department conducted an inspection of the below-referenced facility in response to a complaint. As a result of this inspection, it was determined that the circumstances described below constitute violations of Chapter 26 of the Texas Water Code. You are requested to inform Compliance Coordinator Helmi Merkhi in writing within ten (10) days of steps being taken to be in compliance with this law and to prevent recurrence. ### NATURE OF VIOLATIONS:

On August 7, 2025, at 11:30 a.m., Investigator Eric Bergholtz of this office inspected your Concrete Batch Plant located at 1111 West Loop, North. As a result of this investigation, a violation of the following section of the Texas Commission on Environmental Quality Additionally, Chapter 26 of the Texas Water Code was determined:

**Section 26.121(d)** Except as authorized by the commission, no person may discharge any pollutant, sewage, municipal waste, recreation waste, agricultural waste, or industrial waste from any point source into any water in the state.

Our investigator determined that your facility lacks authorization to discharge wastewater from concrete batch plant operations. Your facility is required to obtain a TXG110000 stormwater permit for concrete batch plants from the TCEQ based on your facility's SIC Code 3272.

Under Texas law you are subject to civil penalties of \$50 to \$25,000 per day, criminal penalties of up to \$250,000 per day or more for each violation, and possible confinement up to 10 years or more. Under the Regulations of Harris County for Storm Water Quality Management, you may be subject to civil penalties up to \$1,000 per day for each violation. A case-by-case review is conducted when each Violation Notice is issued. The ultimate disposition of each case is dependent upon factors such as the nature, magnitude and duration of this violation, steps taken to mitigate the violation, previous violations, and the contents of any response received. In the event that further enforcement action is appropriate, this office may file charges in a court of proper jurisdiction, as provided by law.
