



COLORADO LAWS THAT MANDATE GENDER IDEOLOGY

- **HB19-1120:** Mandates that 12-year-olds control their own mental healthcare (NO parent knowledge/consent)

- **HB19-1129:** Mandates licensed mental health professionals must affirm wrong-sex confused kids

- **HB23-1003:** Mandates mental health screening for all 6-12 graders. Sends them to the STATE’S mental health program, iMatter, without parent knowledge/consent

- **HB24-1039:** Mandates that ALL public & charter teachers must socially transition children to the opposite sex

- **HB24-1170:** Mandates foster families must affirm wrong-sex confusion and transition gender-confused children

- **HB24-1071:** Mandates that transgender felons can legally change their name and erase criminal history (“Tiara’s Law”)

- **SB24-205:** Mandates Artificial Intelligence to abide by gender ideology. Forbids AI from sharing biological truth over “gender identity”

- **HB25-1312:** Mandates gender ideology on EVERYONE. Makes “misgendering” and “deadnaming” illegal: Strips parental rights, compels speech and attacks churches, schools & businesses

- **HB25-1309:** Mandates that insurance must cover ANY/ALL transgender procedures. Mandates Colorado taxpayers to pay for wrong-sex procedures (no age limit, no requirement to be from Colorado) and makes testosterone prescriptions secret.

- **HB25-1109:** Mandates recording “gender identity” on the death certificate, a medical document. Carries criminal penalties for non-compliance

- **SB25-129:** Mandates that wrong-sex butchers are untouchable; eliminates course of action for harmed patients; makes it illegal to investigate wrong-sex procedures

- **HB25-1239:** Changed Colorado Antidiscrimination Act (CADA) to add penalties for “misgendering”

- **HB26-1322:** Mandated licensed counselors, their employers and PARENTS cannot help a child be comfortable in their body/biological sex. It defies SCOTUS decision in Chiles V. Salazar by opening counselors & parents up to unlimited civil liability with burden of proof falling on the defendant

- **HB26-1319:** Mandates that employers must announce and post employees' wrong-sex confusion, educate children about it, and give them time off to get wrong-sex procedures
