

DID YOU KNOW WHAT COLORADO YOUTH CAN CONSENT TO?



Parents No Longer Necessary

Did you know Colorado laws enable youth to pursue gender-transition treatments without parental consent. These new laws pave the way for children to be removed from a parent's care and placed in foster care if the parent does not affirm the child's chosen gender identity.

Transgender Youth Bill of Rights

In the past, biological sex and gender were synonymous and determined at conception. Did you know that now gender identity is defined as a person's **sense** of being a woman, a man, both, neither, or anywhere along the gender spectrum? According to the Colorado Transgender Youth Bill of Rights, youth of all ages have the right to the following without parental consent:

- ➔ Use the name and pronoun that aligns with their gender identity.
- ➔ Participate in school activities and sports that aligns with their gender identity.
- ➔ Use the bathroom, locker room, and overnight room assignment that aligns with their gender identity.
- ➔ Child welfare placement that aligns with their gender identity.

Also, schools are not required to notify girls nor their parents that they will be sharing female safe spaces with biological males.

Pregnancy & Sexual Health



Did you know that Colorado youth of all ages have the right to contraceptives, Sexually Transmitted Infection (STI) testing and treatment, pregnancy tests, HPV, Hep A, and Hep B vaccines without parental knowledge or consent?

Did you know that Colorado youth of all ages have the right to an abortion without parental consent?

Mental Health Care



Did you know that Colorado youth, 12 and older, have the right to mental health counseling services without parent or guardian consent? These services

are usually offered online so parents do not know who is speaking into their youth's life.

Biblical Counseling Prohibited



Did you know that by Colorado law, all licensed mental health providers, including certified Christian counselors, **must affirm a child's stated gender identity?** Christian counselors are

prohibited from providing biblically-based counseling to help a child overcome their gender dysphoria. If they attempt to understand other factors contributing to the child's distress or do not affirm without question, the state can revoke their counseling license.

DID YOU KNOW THE TRANS AGENDA TARGETS YOUTH?



Vulnerable Youth

Did you know our vulnerable youth are being targeted with the transgender agenda? 63% of young people had preexisting mental conditions before announcing they were transgender. Moreover, almost half had self-harmed, and fifty percent had suffered a traumatic event in their lives such as being bullied, suffering sexual abuse, or their parents divorcing. Those factors are already known influences in suicide rates, regardless of any 'trans-stigma.'

Suicide Manipulation



Did you know parents are being emotionally blackmailed to believe the lie "it's better to have a live son than a dead daughter"? A large dataset study shows transitioning procedures do not provide long-term mental health benefits. In fact, one study found adults who had undergone full medical transition had a suicide rate 19 times higher than population-matched controls.

Gender Dysphoria Stats



Did you know studies show that between 74% to 88% of youth would grow out of gender dysphoria by the end of their adolescence if there's no intervention?

Follow the Money



Did you know the transgender movement is a multi-billion dollar industry? The U.S. sex reassignment surgery market was valued at \$1.9 billion in 2021 and forecasted to grow to \$5 billion by 2030. Pharmaceutical companies also profit. Hormones and other needed medications could cost \$200,000 or more over the lifetime of a transgender person. Gender affirming services have become big business for **Planned Parenthood**. They are the second largest provider of hormone therapy for transgender and gender non-conforming patients in the U.S.

Medical Transition Damage



Did you know long term studies have not been completed on the side-effects of puberty blocking drugs and cross-sex hormones? These drugs do not have FDA approval for children's gender care. Reported side effects include loss of bone density, diminished cognitive function, psychiatric problems, and infertility. This process causes irreversible damage.
