From Connecticut: Route 202 North to Westfield, right at lights onto West Silver Street, Boys & Girls Club on right, behind Westfield Middle School. Park in Middle School or Ice Rink lot.

From Massachusetts Turnpike: Exit 3 right onto Rt. 202 South through downtown Westfield. Left on to Pleasant St. (still on Rt. 202 South). Left at lights onto West Silver Street. Boys & Girls Club behind Middle School on right. Park in School or Ice Rink lot.

From Route I-91: Take Massachusetts Turnpike exit from 91 and follow above directions.
