#### Ministers Message

June 1, 2023, marked the beginning of my two-year appointment with Blenheim United Church. Prior to July 1, 2008, I had been a member of the church and then a candidate for ordination from Blenheim United Church. The opening words of Genesis 12 were important for me as I travelled to Toronto for my theological education and then ventured to Saskatoon for an eight-month internship (as it was called then). These words continued to ground me as I left the familiarity of Blenheim United Church and went on to serve at the Guilds Pastoral Charge and Rural United Pastoral Charge. And now God has guided me back to Blenheim United.

When faced with uncertain times or uncharted territory, these words have been foundational:

"Now the Lord said to Abram,
"Go from your country and your kindred and your father's house
to the land that I will show you.
I will make of you a great nation,
and I will bless you, and make your name great,
so that you will be a blessing."

Genesis 12:1-2 (NRSV)

Our lives are a series of "uncertain times" and "uncharted territories." We leave home to go to school, we move to new locations that become our home, we enter the world of earning a living and frequently change locations and/or change jobs. All the while, we remember Abram and his wife, Sarai, who had the courage to step out in faith and to be guided by God's call.

Change, while always with us, can be beneficial. We certainly have a challenge before us – how to be Blenheim United Church without a church building. Abraham embraced the change that God proposed– leave what you know and go to the land that I will show you. Perhaps, Abram had doubts, but he followed God's instruction.

Blenheim United Church has embraced the new reality (even if we doubt it from time to time). We have dedicated people working to keep our church functioning and serving our community. The biggest challenge is to communicate with the wider community that Blenheim United Church is still central to the faith of this community. Our restructured website and our Facebook page are letting the community know that we are still a vital part of Blenheim.

We have taken the Frank and Bernice Coatsworth Fund, which has not been utilized to its potential, and donated the money to Kenesserie Camp for leadership training. During Advent we collected clothing, toiletries, and children's toys to support the Chatham-Kent Women's Centre with their "I Believe" campaign. The refurbishing of the Comfort Room at Blenheim Community Village has begun and is progressing slowly. Look forward to hearing more about that project soon.

As we continue to live into who we are as Blenheim United Church and what our purpose is in the community, let us not forget the words of our creed: "We are not alone. We live in God's world." Let us journey forth grounded in our faith and trusting in the movement of the Holy Spirit to guide us, to energize us, and to equip us for the journey.
