Submit paperwork along with payment

(First come, first served – as long as we have spots available)

- 1. Make sure your youth knows the exact location to wait for the Boys & Girls Club Bus after school.**
- 2. Buses only wait 10 minutes from the time that the bell rings and do not return for students who arrive late.**
 - a. Make sure your child knows to go back to the school office if he/she misses the bus and to call a parent for pick-up.
- 3. Drivers are unable to go into classrooms to pick up students that need to get on the bus. If your kindergartner is riding, be sure to ask a teacher or an office person to help walk your child to the bus on time each day.**
 - a. *Always call our office, no later than 11:30am if your student will not ride. 760-745-0515*
 - b. You might need to arrange for school staff to walk your kindergarten student to the bus every day.
 - c. Buses are unable to wait for students that are not released at the regular bell schedule for grades 1-5.
- 4. The Core BGC Afterschool Program does not enroll Transitional Kindergarten or students who are not yet 5 years old.**
- 5. PM buses start arriving back to the Boys & Girls Clubs between 3:00p.m. – 3:15p.m.**
 - a. The first and last day of school may delay arrival.

**PARENT / MEMBER
INFORMATION**

1. All riders must wear a seatbelt at all times. NO EXCEPTIONS.
2. Everyone must remain in his/her seat during the entire trip, no switching seats once the van/bus has started to move. All personal items including electronics must be in your child's backpack during the entire trip.
- IMPORTANT:**
3. Pick-up: Please call us by 11:30am if your child will not be riding. You are responsible for transportation to the Boys & Girls Club if your child is not present at the scheduled pick up time. 760-745-0515
4. Children are to wait in the designated area assigned by the school.
5. We will NOT return to school to pick up a child that has missed the bus. If for any reason your child misses the bus, please instruct your child to go directly to the school office and call you to arrange an alternate pick up. We are unable to go back for children who have missed the bus due to late dismissal or delayed arrival to the bus stop.
6. **TRANSPORTATION FEES MUST BE PAID IN ADVANCE.** Receipting your payment generates your child's name onto the pick-up roster. Payments for pick up will be accepted by the 24th of the month for the following month. Any payment received later must be arranged in advance with the Branch Supervisor. **Services may be cancelled after the 3rd late payment. NO CHILD WILL BE PICKED UP WITHOUT A COMPLETED CLUB REGISTRATION.**
 - a. **FORMS & PAYMENT:** It is your responsibility to ensure your members and account is current.
 - b. **Payments must be paid in full.** Partial or split-payments will NOT be accepted.
7. Non-registered children will not be allowed on the bus. Transportation paperwork must be on file at the Club office in order for your child to ride the bus/van.
8. Your child should not attend if he/she is sick or not feeling well
9. **Once child is in possession of the bus driver, he/she cannot be released to anyone until they've been driven and checked into the Boys & Girls Clubs.**
10. **Please note: California Administrative Code, Title V, Section 14103 states:**
"Pupils transported in a school bus or in a school pupil activity bus shall be under the authority of, and responsible directly to, the driver of the bus, and the driver shall be held responsible for the orderly conduct of the pupils while they are on the bus or being escorted across a street, highway or road. Continued disorderly conduct or persistent refusal to submit to the authority of the driver shall be sufficient reason for a pupil to be denied transportation."

11. If your child violates transportation program rules, the following consequences are in place: (Steps may be skipped depending on the severity of the offense.)

1st notice: Written Warning

2nd notice: 1 day suspension from bus program

3rd notice: 3 day suspension from bus program

4th notice: Dismissal from the bus program

12. All children must be picked up from the Club by 6:00pm. **Services may be cancelled after the 3rd late payment**

PLEASE REVIEW THE FOLLOWING BUS & CLUB RULES WITH YOUR CHILD.

School transport is being provided as a convenience to parents/guardians of our members. It is your child's responsibility to:

1. Respect the Leader/Driver
2. Arrive each day on time at the Club's designated meeting spot

10. No eating or drinking (water is allowed) on the bus or van
11. No leaving trash or personal items on the bus or van
12. Keep voices down and in a respectful tone
13. No animals allowed on the bus. NO EXCEPTIONS
14. Keep aisle clear at all times
15. Any vandalism to the bus will be paid for by that member's parents/guardians
16. Shirts & shoes are required to ride the bus. NO EXCEPTIONS
17. Stay with your assigned group at all times. Never stay in an area without a staff member present.
18. Place your snack in your cubby when you enter the building. Snacks will only be permitted to be taken out during snack time.
19. Chewing gum is not allowed.
20. Do not talk or interact with strangers at any time.
21. Climbing on trees of any kind is not allowed.
22. Do not play with animals, dead or alive.
23. Stay within Club boundaries set by the staff.
24. Keep your hands to yourself; no fighting or hitting.
25. No foul language. Use courteous language.
26. Food or drinks are only allowed in the gyms.
27. Walk; DO NOT RUN. (Unless as part of an activity).
28. If you and another child have a problem, tell a staff person.
29. It's your Club; let's take care of it. If you see trash on the ground, pick it up. If you see a mess, clean it up. Use equipment safely and properly.
30. Treat others as you would like to be treated.
31. Leave all personal belongings at home.
32. Use the Club phone only for emergencies.

Walking Program Form

Welcome to the Boys & Girls Clubs of Greater San Diego's walking program. We are pleased that you have chosen the Club to provide safe and fun after school activities for your child. In order to provide the safest program possible, the following rules will be enforced. Please review them with your child.

1. Please call us at **(760) 745-0515** at least 2 hours prior to pick up if your child **will not** be walking to the Boys & Girls Club. You are responsible for transportation to the Boys & Girls Club if your child is not present at the scheduled pick up time.
2. Children are to wait in the designated area assigned by the school.
3. We will NOT return to school to pick up a child that has missed the staff-supervised walk. If for any reason your child misses the group, please instruct your child to go directly to the school office and call you to arrange an alternate pick up. We are unable to go back for children who have missed the walking program due to late dismissal or delayed arrival to the designated meeting spot.
4. **AFTERSCHOOL FEES MUST BE PAID IN ADVANCE. Receipting your payment generates your child's name onto the pick-up roster.** Payments for the Afterschool Program will be accepted by the 24th the month for the following month. Any payment received later must be arranged in advance with the Branch Manager. **NO CHILD WILL BE PICKED UP WITHOUT A COMPLETED CLUB REGISTRATION.**
5. Non-registered children will not be allowed to walk with the group. Transportation paperwork must be on file at the Club office in order for your child to participate in the walking program.
6. Your child should not attend if he/she is sick or not feeling well
7. **Once child has checked in with Club staff, he/she cannot be released to anyone until they've been walked to the Boys & Girls Club and checked into the program so that contact can be verified before release.**
8. If a parent or child violates walking program rules, the following consequences are in place: (Steps may be skipped depending on the severity of the offense.)

1st notice: Written Warning

2nd notice: 1 day suspension from walking program

3rd notice: 3 day suspension from walking program

4th notice: Dismissal from the walking program
