### Letter of Intent for Event Participation & Hold Harmless Agreement

In consideration for receiving permission to participate in the above Quincy Chamber of Commerce sponsored event, I hereby **release, waive, discharge and covenant not to sue** the Quincy Chamber of Commerce, County of Plumas, their officers, agents, servants, or employees (hereinafter referred to as releases) from any and all liability, claims, demands, actions and causes of actions whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or any of the property belonging to me, **whether caused by the negligence of the releases**, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted.

I am fully aware of the risks involved and the hazards connected with the activity, including, but not limited to **risks that may or may not be foreseeable by me or the releases**, and I hereby elect to voluntarily participate in said activity with full knowledge that said activity may be hazardous to me and my property. **I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death**, which may be sustained by me, or any loss or damage to property owned by me, as a result of being further engaged in such an activity, **whether caused by the negligence of releases or otherwise**.
3. I further hereby agree to indemnify and hold harmless the releases from any loss, liability, damage or costs, including court costs and attorney fees, that they may incur due to my participation in said activity, **whether caused by negligence of releases** or otherwise.

I understand that the Quincy Chamber of Commerce does not maintain any insurance policy covering any circumstance arising from my participation in this event or any activity associated with or facilitating that participation. As such, I am aware that I should review my personal insurance portfolio.

It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns, and personal representative, if I am deceased, and shall be deemed as a **release, waiver, discharge and covenant not to sue** the above –named **releases**. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be constructed with the laws of California.
