Barcodes can be obtained either via U.S. Mail or by visiting the management office at:

If you do not have a printer at home, barcode application forms can be obtained from either the South Guardhouse at Tampa Road and East Lake Woodlands Parkway or the North Guardhouse at East Lake Road and Woodlands Boulevard. Please drive through the visitor lane to obtain the application form from the security officer on duty.

If you have a printer at home, proceed to the ELW website at ELW-FL.com, click on ELWCA Community Association, then Controlled Access. There are four files that you will need to read and complete as follows:

Barcode Decal Information
Barcode Label Placement

Should you elect to obtain your barcode in person at our office, please be advised that the following rules are in effect:

- **Please complete all paperwork prior to arriving at the office**
- Barcodes will be issued Monday through Friday between 8:00 AM and 11:45 AM and from 1:00 PM to 4:00 PM.
- No PETS or unsupervised children will be permitted in the office
- No food, drinks, or smoking will be permitted in the office
- No vulgar language, yelling or any type of verbal or physical abuse will be tolerated

Should you elect to obtain your barcode via U.S. mail, please mail your barcode request form, the signed waiver, proof of registration and payment to the address above.

EASTLAKE WOODLANDS BARCODE & WINDSHIELD DECAL FEE INFORMATION - EFFECTIVE 1/1/21

ELWCA MEMBERS & CONTRACT COMMUNITY MEMBERS:

Owners:

Proof of residency: Either a driver's license reflecting Eastlake Woodlands address, warranty deed or closing statement reflecting a recent purchase.

Owner's Cost: \$20.00 for the first vehicle barcode and windshield decal and \$15.00 for the second and each subsequent vehicle barcode and windshield decal, up to a maximum of five (5) issued per address.

Renters:

Renters must provide a copy of the lease. Barcode decals will NOT be issued to renters with a lease term of less than 3 months. You can obtain an ELW windshield decal only for \$5.00

Renter's Cost: Cost: \$30.00 per vehicle for a barcode and windshield decal. Replacement barcodes and windshield decals are \$10.00 for new vehicles or worn or defective barcodes.

Owners & Renters:

Car Registration must be presented for each vehicle
One barcode and windshield decal issued per vehicle.

Replacement barcodes and windshield decals for a new vehicle or worn or defective barcodes are \$10.00 per vehicle.

UNBOUND ASSOCIATION OWNERS (NON-MEMBERS): OWNERS WITHIN CONDO 1-7, CLUSTER 2, CYPRESS 1-3, WOODLAND ESTATES, LAKE ESTATES, PATIO HOMES AND QUAIL FOREST

Owners:

- Proof of residency: Either a driver's license reflecting Eastlake Woodlands address, warranty deed or closing statement reflecting a recent purchase.

There is no charge for barcodes or windshield stickers but owners are responsible to pay \$1.00 mailing fee.

Renters

- Copy of the lease. Barcode decals will NOT be issued to renters with a lease term of less than 3 months. You can obtain an ELW windshield decal only for \$5.00

Cost: \$30.00 per vehicle for a barcode and windshield decal. Replacement barcodes and windshield decals are \$10.00 for new vehicles or worn or defective barcodes.

Unbound Owners & Renters:

Car Registration must be presented for each vehicle
